JUDGE HUNTER HAS BUSY WEEK HANDLING COLLECTIONS UNDER FIFTY DOLLARS

Disposing of as high as seven cases per day, Justice of the Peace L. J. Hunter is kept quite busy every day in the "Poor Man's Court." Since this feature of the justice court was inaugurated many creditors have taken advantage of the new law and are endeavoring to make their collections in this way.

Suit may be entered against anyone owing a bill of less than \$50 without any charge. The complaint may be filed in the justice court, the notice sent out by registered mail and if defendant does not appear when notified to do so an execution is thereby entered against him and a judgment secured. After execution is entered, then the cost begins to accumulate, as it is handled in the regular way.

All expense is eliminated. No attorneys are allowed. No assignment of bills is permitted, and there is no possible chance for collection agencies to infringe on the law and reap any benefits whatever from the new court. Of course, after judgment is given, then it is up to the creditor to collect, and this part of the transaction may incur expense as heretofore.

Handling of small amounts in this way is proving to be of great benefit to creditors, as before many small bills were let slide along, because it would take all the account was worth to collect it under the old system, and while it means a lot of work for the Justice of the Peace, it is a blessing for those who have numerous small accounts that are hard to collect.
