**LOMITA CHURCH NOTES**

The Christian, the World's Bible, was the theme of the morning sermon from the texts: "Ye are the salt of the earth." "Ye are the light of the world." How simple and easy to be understood are these figures of speech. Jesus does not say: "Ye carry the salt of the earth in your message. He does not say: "The light of the world is in the Gospel you are to preach. The message is indeed salt and light. It must be embodied in a human being, yea, in your characters and in your lives are the salt of the earth and the light of the world. The duty of the lamp is to give light. The lighthouse is to shine. The street lamp, to be of any use, must shine. "Let your light so shine before men that they may see your good works and glory your Father in heaven."

In the evening the pastor spoke on the Surprises of Sin, using the text: "But what is thy servant, who is but a dog, that he should do this great thing?" There is the possibility of sin in every human heart. We know not how strong we are until we are tempted. Life's perilous years are not always the years of youth. When David had fought his battles he yielded to his great temptation. When Solomon was old his heart turned from the Lord. The only safe course is to commit our lives to the leadership of Jesus Christ.

At the Intermediate Christian Endeavor meeting Miss Mills gave an interesting account of her experiences with the Harry Rimmer evangelistic tour in Humboldt County the past summer.

Next Sunday will be observed as Rally Day. The Sunday School will have a special program at 9:45 a. m. Parents and friends are cordially invited to be present. Promotion exercises will be part of the program and an offering for colporteur work among foreigners in our own country will be received.

**THE CHURCH AND LABOR**

(The following was contributed for publication and does not necessarily represent the views of the editor. But in fairness to all, space is herewith given.)

May I have a little space in the "News Letter" commenting on the Church Notes of last week's issue especially to a question from the Rev. John McDowell, D. D.? It has been my firm conviction for years that our present system of civilization is a failure. The eminent layman says: "Law has failed, education has failed, science has failed, organization has failed, labor unions have failed, employers' associations have failed." In a word every form of industrial organization based on force or selfishness has failed. Love, and love alone, can solve our industrial problem. I believe he should also have included that the church has failed. For has not the church played an important part in the framing of our laws and in helping to enforce them?

During our last war an apostle of love and peace asked permission of the Department of Justice to print the Sermon on the Mount without comment, for distribution among the people. He was refused on the ground that "it would be considered pro-German." Has the church tried to uphold this apostle of love? No, he had to keep silent or go to jail. It is true that the church has of late manifested a desire to be more friendly to labor, because labor is drifting away from the church to an alarming extent. I have before me a report of the National Civic Federation, the well-known organ of big business, roundly condemning the stand of the church and threatening to withdraw financial support if the church persists in its stand toward labor, the salt of the earth.

I agree with Doctor McDowell that "love and love alone will solve our industrial problem." I also feel that the church has no right to claim the friendship of labor unless that friendship is manifested through love and love through justice. The Good Book tells us: "The rich man's wealth is his strong city; the destruction of the poor is their poverty." The strong city of olden times was the walled city. The wall of the present time is our laws. So long as we recognize as legal the right of one to live from the labor of another, the right of man to exploit man in different forms, we cannot have peace. Where exploitation exists love does not abide. Whenever the church will show its friendship to the cause of labor by giving its moral and financial support as it has to the cause of prohibition, since the traffic of man exploiting man is far worse in its effects than the traffic in liquor, then I will support the church with my whole heart and strength, morally and financially.
