obtain bids from contractors of his with the plans selected.

"(c) Select a lot anywhere within two miles of the shops, on a good road, select a standard plan or furnish selection. If location, plans and bids are approved, the company will purchase the lot (provided it can be obtained at a fair price) and let a contract for the house. Special plans must be such that house would be suitable for another employe in case it is given up.

"Homes will be sold to employes at actual cost, including cost of plans, supervision of construction, interest, taxes and insurance during construction, and all expenses incurred on each home up to the time it is ready for occupancy. There will be no charge for accounting or overhead expense.

"Net amount by the company (that is, difference between total cost and amount of first payment) will not exceed \$4,000. This will not prevent an employe from selecting a more expensive home, within reasonable limits, provided his first payment is large enough to bring the balance down to \$4,000.

"First payment to be not less than \$100, payable \$50 with application and \$50 when house is ready for occupancy. Balance to be deducted from pay roll at rate of one per cent per month, to be applied first on interest and then on principal, providing buyer is not in default on taxes, insurance or other charges. However, buyer may make additional payments, at any time. Interest charges at 6% per annum, to be adjusted and account balanced every six months, and statement furnished buyer. Monthly deductions to be made from last pay of each month, starting in month when house is ready for occupancy.

To date there has been more than \$5 employe take advantage of the liberal offer of the company in securing homes on terms not available on the open market and it is noteworthy that in not a single instance has a purchased home reverted to the company. The same business-like methods which characterize the handling of the affairs of the company is exercised in connection with the purchase of homes and many expressions of entire satisfaction have been received.

The new appropriation will now make the revolving fund \$400,000 and the plan of the company is to use the excess earnings of this huge sum in building additional homes. Under the present excess income the company is able to erect one additional home a month and it is expected that with the increase under the last appropriation they will be able to erect from one and one-half to two homes a month.

## Box Lunch Shop

### To Open Monday

The Rathbun Box Lunch Shop which will open its doors to the public next Monday, will fill a long felt want among the thousands of workmen, whose time is limited during the noon hour, and to the wives of these workmen, who are frequently at a loss as to what to prepare for their husband's luncheon.

C. E. Rathbun and wife of Akron, Ohio, and more recently of Long Beach, are said to be the originators of the "box lunch," that consists of a varied assortment of good things to eat and contained in a neat, clean cardboard box, ready for use by the hungry and hurried mechanic.

Mrs. Rathbun, who personally supervises the preparation of the food states that she will serve "swedish meat" sandwiches, a piece of pie, a cookie or piece of cake and fresh fruit in each box, the total cost to be twenty-five cents.

For those desiring something to drink with their lunch the Rathbuns have hit on a novel scheme that of serving piping hot coffee or cold milk in a paper container that holds a pint, at an additional expense of ten cents.

In addition to box lunches Mr. Rathbun is preparing to install a hot plate in his place in the Brighton block, formerly occupied by the Tolson Transfer company, where both hot and cold lunches will be served at a regular rate counter that is being installed.
