ORDINANCE No. 152

An Ordinance of the City of Torrance Amending Ordinance No. 41.

The Board of Trustees of the City of Torrance do ordain as follows:

SECTION 1. Section 6 of Ordinance 41 is hereby amended to read as follows:

"No person, firm or corporation shall conduct, manage, or carry on a plumbing business, or do any plumbing or house drainage work for pay or hire within the City of Torrance after the passage of this Ordinance, without first obtaining a license from said City so to do, or a permit as hereinafter mentioned.

It shall be the duty of the City Clerk to issue such licenses to the persons, firm or corporation applying therefor subject to the conditions of this Ordinance. The license fees for carrying on the business of doing plumbing work in the City of Torrance are fixed by the business license Ordinance of said City.

Every applicant for license before being granted same, must present certificate of having


