

Situated at 2315 Sonoma avenue is this delightful little, 5-room bungalow built by M. L. Darling for Mr. and Mrs. L. L. Nelson. Light tan stucco in a rough finish and topped by a red tile roof, completes this attractive Spanish home. A massive oak door swings open to admit the caller to a small entrance hall, with an inset table directly ahead for wraps, and doors to the living room on the left and a bedroom on the right. The living room is ample with one large window on the front and two smaller windows, one on each side of the open fireplace. Both the living room and the dining alcove, between which there is an arched opening, are finished with an antique rough finish, in two shades of grayish tan. The same finish has been carried out in the woodwork in the rooms. Ceilings are paneled and cornerless. In the dining alcove, an attractive arrangement is made by a slight projection of the room, and three windows, that are placed as a half of a hexagon. There is also a corner cupboard, made doubly attractive by the antique finish woodwork. A living door opens into the kitchen finished in cream with white trim. Cupboard doors are quite different than the usual in that they have a raised diamond outline on them, giving it a diamond panel effect. There are three of these large doors above, and many doors and drawers below the sink level for storage. The drainboard is white tile with orchid trim, and above the drain are two windows, between which is a spice cupboard with a mirror in the door. On the service porch off the kitchen is the storage tank and laundry trays. The tank is set high in one corner, and rests on a cabinet built to contain soiled clothes. The outer door, opening on the side yard, is but a few steps from the garage. A door from the kitchen shows a roomy square hall, which has a large linen closet with the diamond pattern carried out on the doors and doors leading to every room in the house with the exception of the dining alcove. This gives a small house one of the most convenient floor plans obtainable. The back bedroom, finished in old ivory and cream, is fitted with a large clothes closet which the door divides into two sections. Cross ventilation has been provided in both the front and back bedrooms. Pale orchid walls, with a deeper orchid trim for the woodwork, is the color scheme of the front bedroom. It is accessible through either the entrance hall or the main hall. This room also has a large closet, the door to which has a full length mirror. In contrast to the riot of color being used in most of the new houses, the bath of this bungalow is in white, with a black tile trim. There is a built-in chest. Floors throughout the house are hardwood and all walls have been stippled.
