Construction of Highway Along Beach Protested
 University of Redlands Fights Rerouting of Roosevelt Highway
 The controversy over the route to be followed in connecting Lincoln boulevard, also known as Roosevelt highway, with that section of the state highway leading northerly along the coast today had brought a protest from the University of Redlands, addressed to county officials.
 "We understand that concerted action is being made to have the new state highway extend along the beach frontage instead of coming up out of the canyon and down Lincoln boulevard as originally planned," the communication from George P. Cartner, business manager, informed the board of supervisors.
 "There are four reasons why we protest the state spending a larger sum for a road that will not be nearly as serviceable as the one originally planned. First, the original route is the most direct. Second, it would be free from sharp curves. Third, there would be less beach traffic and there would be freedom from concessions. Fourth, the congestion in the heart of the Santa Monica business district would be avoided."
 The University of Redlands is the owner of property at the corner of Lincoln and Santa Monica boulevards.

Harbor City Man Asks Probation On Manslaughter Plea
 Victor Kolek, Harbor City resident, pleaded guilty to charges of manslaughter for the fatal shooting of Joseph Wojcik, son of the U. S. S. Virginia, when arraigned in Los Angeles superior court and applied for probation.
 Hearing on Kolek's probation report has been fixed for September 20, in department 21 of superior court, at which time a second court against him also is to be disposed of. Kolek was charged with murder, but manslaughter is a lesser offense.
 The fatal shooting occurred at the home of Robert T. John, 26123 Oak street, Lomita, last June 24, when the two became involved in an argument over a trip to Santa Ana. Kolek told deputy sheriffs the gun had fallen from his pocket and that in picking it up it had been discharged into Wojcik's chest, killing him almost instantly.
