Sets Enrollment Record OXFORD, O. (U.P.)—An all-time enrollment record was set by Miami University at the opening of its current term, when 2468 students matriculated. W. C. at Narbonne High School Narbonne students have had the privilege of hearing two well-known speakers at recent assemblies. Lt. C. E. Jones (retired) of the U. S. navy, was the guest speaker at an assembly, October 25, in observance of Navy Day, while Coach Bill Spaulding of U. C. L. A. addressed the Gauchos Tuesday, October 30, at a student body assembly.

Lt. Jones gave a review of the navy from the days when ships were rowed by slaves up to the present-day electrically driven ships. He also spoke of the important role that will be played in future wars by the naval air force, which he declared was the offensive arm of the navy. Marc Goodnow of the journalism department of U. S. C. spoke to the journalism class, October 22. Another noted speaker will be Major School of the Northwest Mounted Police, who will lecture at a combined A. S. B. program on December 3.



### Hints For Motorists

(The Herald today presents another group of an instructive series of questions and answers related to various phases of motor vehicle ownership and operation in California. Authority for the answers is Ivan Kelo; general counsel, Automobile Club of Southern California.)

Question—How is it possible to prepare a minor for an operator's license examination since it is unlawful for him to operate a car until a license has been secured?

Answer—The department of motor vehicles has established a procedure to cover this situation. When application is made for a minor's operator's license an instruction permit must be secured, and during the period for which it is issued a minor may operate or learn to operate motor vehicles when accompanied by a licensed operator. At the conclusion of the instruction period a regular examination is given and if satisfactory a permanent license is then issued.

Question—Must a bicycle rider observe the same traffic rules which a motorist is required to obey?

Answer—Yes. The term vehicle as defined in the California Vehicle Act specifically includes bicycles. The driving regulations in the act are defined as applying to all vehicles and must, therefore, be observed by bicycles.

Question—What is there to prevent a person whose operator's license has been revoked, or suspended for applying for another or using a fictitious name and address?

Answer—By virtue of the seventh subdivision of Section 51 of the Vehicle Act it is unlawful to use a false or fictitious name in an application for the registration of a vehicle or for an operator's or chauffeur's license, or to make any false statement or conceal a material fact in such application. A violation is made a criminal offense and is punishable by \$500 fine or six months imprisonment or both.
