## Aerial View, First Federal Subsistence Homestead Tract



The first government subsistence homestead project in California is now nearing completion at El Monte, according to officials of the United States Resettlement Administration, who expect the homes will be ready for occupancy during the summer.

In the meantime, selection of 100 families for the El Monte homesteads and an additional 40 for a similar tract near San Fernando is being made from a total of 4,858 applications.

Five different types of houses with 17 variations in design are being used in the El Monte project. A tract of land ranging in size from 64-hundredths to 94-hundredths of an acre goes with each home which includes a living room, dining room, kitchen, bathroom and from one to four bedrooms.

Living rooms and bedrooms are to be heated with natural gas wall furnaces. A natural gas water heater is installed in each home, and there are connections in the kitchen for a gas range and refrigerator. Special lines for service to the entire tract at El Monte were installed by Southern California Gas Co. and at San Fernando by the Resettlement Administration of the Department of Agriculture.

It is selling these homesteads to selected families having not less than \$50 a month net income, and a \$100 a month income. Prices range from \$2,500 to \$3,800, and payments are spread over a 30-year period.

Citrus and avocado trees are now being planted, and it is planned to provide each homestead with deciduous fruit trees and berry bushes. Five acres are reserved for a community park with recreation building, and another five acres are set aside for a school house. Two miles of rock and oil streets are under construction.

A \$5,500 community building situated in a demonstration garden on 1 1/2 acres has just been authorized. According to present plans the community canning kitchen in the building will be equipped with modern natural gas cooking appliances.
