WATER WELL is sensitive to QUAKES

A municipal water well which is more sensitive to distant earthquakes than it is to those nearby, is disclosed in the annual report of the board of water and power commissioners for the fiscal year just closed. The well is located near Van Nuys boulevard and Caterbury street in San Fernando valley.

Water state records installed on the well record the fluctuations of the water level, while the time and location of the various shocks have been checked by the California Institute of Technology.

The greatest fluctuation—six-tenths of a foot—was recorded at 3:25 p. m. November 26, last, during a quake which was centered in Baffin Bay, Greenland, while during a quake centered in Southern California, October 2, last, at 1:10 a. m., the fluctuation was but 1/4 of a foot.

There were 12 records of fluctuations due to earth shocks during the fiscal year, the smallest one one-hundredth of a foot—occurring during a quake centered in southern Arizona.

How Realism is Achieved in Diorama Making



At the top, left, is a close-up of diorama manufacture as carried out in the making of the Ford Exposition building diorama. W. E. Wagner is shown carefully measuring a part of the Ford model V-8 included in the Japan diorama in the rotunda of Balboa Park, San Diego. Note the Japanese figures featured to the right of the car. Upper, right, diorama in the Ford Exposition building depicts the mining of sillimanite high above the clouds. An unusual effect is obtained by a model made of wood and a dill, parts of which are metal and parafin wood finished to resemble metal. The large photograph directly above is of the finished Japan diorama after its placing in the Ford Exposition building. The car on which Mr. Wagner is shown working in the upper photograph is completed and in the diorama is placed in the left foreground.

The making of dioramas is an art in itself, according to Henri Marchand, of the Diorama Corporation of America, who supervised the making of models and the painting of dioramas for the Ford Exposition Building, Balboa Park, San Diego. From 25 to 30 men worked at the task of diorama making for three months prior to the completion of the Ford Building.

The first step in assembling a diorama is the preparation of a sketch showing the size, color and shape of the proposed painting. Then a wooden panel is erected and the back is painted according to the design. When this is done, the figures in the foreground are made in full relief and set in place.

From this state on the process is one of blending colors and figures between the intervening spaces so the illusion of distance and full perspective is obtained. Cardboard models are used for size and contour. The trial and error system results in perfect blending of colors and true perspective.

Japanese Boy Dies In Auto Accident
