Dog Licenses Are Now Payable

Dog owners in Torrance may step into the city clerk's office any day now, and pay up for Fido's identification tag. Licenses became due on July 1, and under the new ordinance adopted recently by the city council, the ante has been raised to \$2 for male or spayed female dogs, and \$3 for females. Licenses may be paid either at the city hall or to the collector who is now calling at the homes. Time limit on payment is 60 days, or about Sept. 1, after which a penalty charge of 50 cents additional will be made.






