PAY FRANCHISE . . . A check for \$38.76 was reported received by City Clerk A. H. Bartlett from the Texas Oil company to the city council Tuesday night. The payment was for a pipeline franchise.

100 PERCENT . . . Every member of the council, City Treasurer Scott Ludlow, City Attorney C. T. Rippey, City Engineer Frank R. Leonard and City Clerk Bartlett will attend the dinner-meeting of the Los Angeles County League of California Municipalities at Huntington Park tonight.

SEEK IMPROVEMENT . . . A request from the Redondo Chamber of Commerce that this city pass a resolution urging the Pacific Electric to replace its "obsolete equipment, provide more frequent service, smoother roadbeds and more comfortable coaches" was referred to the local chamber. A similar resolution was passed by the Redondo civic group which now seeks to have all beach cities in the South Bay district do the same.

DRAINAGE WANTED . . . A. Keagy of Puente, owner of farm land fronting on Hawthorne boulevard in Meadow Park tract, wrote the council calling attention to the flooded condition of his land and stated that his tenants are requesting him to give up a half-year's rental because they are unable to use the property. City Engineer Leonard will write Keagy and explain what has been done to drain that area and inform the owner that attempts are being made to obtain a WPA project for permanent solution of the problem.

GRANT FRANCHISE . . . After considerable discussion the city board decided to grant the Pacific Electric's request for a 50-year power line franchise on Prairie avenue for the re-routing of the "railway" of Watts-Redondo feeder line. No revenue will be forthcoming for the city, it was expressly stated. The line will parallel the Southern California Edison's power lines.

SAVES CITY MONEY . . . On recommendation of City Engineer Leonard, the council authorized the payment of \$285 incurred in connection with the DeMuth condemnation case in WALTERIA from the funds received from the state quarter-cent gasoline tax. This the litigation to acquire property for street opening and improvement purposes will cost nothing from its regular funds.

TO INSTALL SIGNS . . . Councilman James Hitchcock recommended that the city purchase a reflector sign costing \$18.65 to identify the community of WALTERIA and place it at the intersection of Newton street and Highway 101. This was approved and Hitchcock also reported that the Auto club will install other reflector signs without cost at Hawthorne boulevard and 101 directing traffic to WALTERIA. A similar marker inscribed "Slow" will be installed by the City on Torrance boulevard east of Border avenue to minimize speed at that wide intersection.

PASS LIBRARY BUDGET . . . By resolution the council approved the recommendation of the public library board in retaining the services of the county library for the ensuing fiscal year at a cost of about \$5,900.

NEXT MEETING DATED . . . Unless a special session is held between now and April 27 the next meeting of the city council will be held on that date.
