

# WPA Crossing Guard and Aged Man Held for Morals Trials

meaning of truth in her answers. "Little girl who tell lies gets a licking," the witness, who is in the first grade in school, said. Daigh's wife was in court during the hearing and his mother was there before the examination started. She left at the opening of the session after telling the deputy district attorney that her son may have been mentally unbalanced.

"She claims that Daigh, besides having his left hand shot off when a boy and being seriously injured about his body by gunshot wounds in an accident, fell down 14 feet into a cellar and suffered a skull fracture," Whichello said later. "This may indicate that when Daigh is placed on trial he will plead guilty by reason of insanity. We will keep him under close observation at the county jail from now until his case is to be heard."

A few minutes after Daigh and his wife left the courtroom, the aged Hollingshead was brought in. Nearly stone-deaf, he had to have questions shouted to him by Capt. Stroh. As each of his five little accusers, three of them sisters, ended her testimony he was asked if he had any questions to ask.

"I don't want to ask any—how could I when I couldn't hear what she said," he responded querulously. Hollingshead was informed that a complete transcript would be furnished him for study in the county jail. He is charged with indecent actions and making an obscene remark to a 10-year-old child. At the conclusion of the hearing, the prosecutor declared that he would file three separate felony charges against Hollingshead.

At Whichello's request, Judge Lessing increased the aged man's bail from \$1,500 to \$5,000 when the defendant was remanded to the custody of the sheriff. The prosecutor said that he had reason to believe that Hollingshead's relatives, a son being mentioned, might succeed in getting him released for the lower bail.

**Occurred At City Park**  
The gray-whiskered oldest's alleged disgusting actions and foul remark were declared by the little girls, 13, 11, 10, nine and seven years of age, to have been made at the city park playground on Sunday, June 27. The children were playing in the sand pit and on the Maypole swing when he appeared and made his indecent advances, the youngsters testified.

Each of them, save one who cried when first placed on the witness stand, recounted the same stories they had previously told police officers when the authorities were called to investigate the old man's actions about the park. The father of one of the youngest children attended his daughter in court but neither parent of the three sisters was present.

**Denies Evil Intentions**  
Sergeant Ernest M. Ashton, the last to be examined, testified that he was one of the investigating officers and that Hollingshead made this comment when he was being booked at the police station last Saturday morning.

"He said he had no evil intentions against the girls. He said that his actions may have looked bad to an adult but that he had nothing of that nature in mind," the officer reported.

Two of the little tots, a 13-year-old, said that the defendant had given them candy before making his advances, which occurred as he pushed them around on the Maypole swing. All of them said they didn't "like to have him around."

**Left Hand Shot Off**

The aged Hollingshead was picked up as he was leaving his room at the Brighton hotel on Cabrillo avenue an hour after Daigh was arrested. Sergeant Ernest Ashton and Officers Perkin and Bennett brought him to the city jail where he, too, was held on \$1,500 bail. In addition to the morals charge placed against the grey-whiskered, shabbily-dressed oldest, he is accused of making lewd remarks in the presence of two sisters, 13 and 11 years old, and two other little girls, eight and six years of age.

All four and Mrs. Anna Wilson, 2922 23rd street, a WPA supervisor at the city park playground, where Hollingshead is alleged to have committed his indecencies, positively identified him at police headquarters here Sunday morning. The recreation supervisor reported Hollingshead's activities about the park to police Saturday.

The aged man, who is almost deaf, declared that he did not do anything that was against the law," when arraigned before Police Judge Lessing Tuesday morning. At that time he was given the complaint to read—because of his lack of hearing—and also a statement informing him of his constitutional rights to retain an attorney and cross-examine witnesses. He was returned to jail, as was Daigh, to await the preliminary hearing.

Hollingshead has lived here for ten or 12 years, making his living by doing odd jobs for residents.
