

Delegates from practically all of the Harbor district communities were in attendance and heartily applauded the selection. less and Paul Calvert, and the guards, Barney Meyers and Harvey Robinson, all of Los Angeles, were questioned by City Judge Robert Lessing who was aroused from sleep to attend to their cases. The disturbance was settled when Meyers and Robinson paid Lawless and Calvert \$3.50 for the broken plate.

This ruction occurred about 3 a. m. Bruneman had been received in a serious condition at the hospital about 9:30. Witnesses told Chief Peterson that two men followed the "big shot" and Miss Eatone along the Strand. The two shadows merged when the shots were fired. Both assailants are believed to have been fired together.

"Our telephone has been ringing constantly for hours," Miss Esther Z. Maxwell, superintendent of the hospital, said Tuesday morning. "Every newspaper in Los Angeles and all of the agencies like United Press, Associated and International News have been calling for the latest reports on the case. Then we've had several hundred visitors here during the past 12 hours so you see we have been kept unusually busy."

Wife At Hospital

One of the visitors allowed within Bruneman's room by the guards, who described themselves as private detectives, was a Mr. Harris, who said he was a business associate of the wounded man. Harris was allowed to see Bruneman alone for several hours early Tuesday morning after the latter had recovered consciousness. He told investigating officers and reporters to "keep my name out of this."

Another visitors was Bruneman's wife, it was learned. His beach companion, Miss Eatone has not been seen around the hospital. Officers termed the shooting as "an outbreak in gangdom over gambling rackets."

Case Re-opened

The checks involved in the Caress case were made payable to Bruneman, although he pleaded no connection with the actual shooting. During their trial for assault with a deadly weapon the gangsters involved with Bruneman were given heavy police guard to prevent other gangsters from reaching them. At the end of the trial Bruneman and his three co-defendants were acquitted.

Later the case was re-opened on kidnapping charges and a search for Bruneman was started. Bruneman's asserted aides were convicted. Three years later he surrendered to police and announced himself ready to stand trial on a charge of being an accomplice in the Caress episode.

When he appeared in court later he said he was forced to take part in the abduction and to be the go-between in receiving the ransom checks. He was later acquitted of the charges.

Pair in Court Friday

The other accused morals offenders are now in the county jail awaiting Superior Court trials. Two of them, Ralph Daigh, 37, WPA crossing guard, and Granville Hollingshead, deaf 44-year-old odd job worker, will have their preliminary hearing tomorrow morning in Department 41. Daigh is accused by the father of a six-year-old girl, while the aged Hollingshead was held on testimony given by other little girls.

Albert Jewell, 49, who was arrested here July 9 and held to answer four possible counts of molesting young girls, will make his first appearance in Superior Court August 2.

Asked if the latest arrest—that of young Brenenstahl—came as the result of information furnished by the recently organized "Torrance Vigilantes," Police Chief Calder said that the investigation was made after parents of the children involved had complained to police. The "Vigilantes" were formed here by L. E. Stanley, former local motorcycle officer now employed at the Columbia Steel plant.

The purpose of the organization, according to its founder, is to "rid Torrance of sex crimes and make this city a safe place for young girls and women." Sixty members are said to be enrolled, all of them unknown to each other but accounted for by Stanley, who says the "Vigilantes" will support the police in any way possible and discourage mob violence.
