



UNIT "A":

(1) Furnish and install one horizontal centrifugal booster pump with one 125 H. P. General Electric Starter or equal, pump to be direct connected to a 125 H. P., horizontal motor, mounted on common cast iron bed-plate securely fastened to foundation.

UNIT "B":

(1) Furnish and install one horizontal centrifugal booster pump with one 125 H. P. General Electric Starter or equal, pump to be direct connected to a 125 H. P., horizontal motor, mounted on common cast iron bed-plate securely fastened to foundation.

(2) Each bidder shall furnish with his bid full details and drawings of the construction of the pump showing internal construction and approximate overall dimensions; copies of curve indicating head capacity, break horsepower and efficiency characteristics of the pump quoted. He shall also furnish full details of the construction of the motor including overall dimensions and such cuts and sketches as will fully describe its construction.

(3) Furnish and install all necessary pipes, fittings, facilities and labor and connect booster pump to suction and discharge lines of waterworks and pressure tank, making all necessary changes at booster pump house for such connection.

(4) Torrance Municipal Water District No. 1 shall be guaranteed against defects in workmanship and material for one year after unit is in operation.
