

PRESERVATION OF BIXBY AND NIGGER SLOUGHS IS URGED

The California History and Landmarks club this week injected itself into the discussion as to what to do with Nigger and Bixby Sloughs, and invited members of the board of supervisors to attend a meeting in Inglewood next Monday afternoon to consider its preservation. Mrs. Bertha H. Fuller is president of the club.

Members of the board of supervisors have been trying to decide whether each is a drainage or a flood control problem, and nothing can be done until federal financial assistance is obtained, county officials have told property owners concerned.

"We are deeply interested in discussion about draining old Machado Lake, now known as Nigger Slough," Mrs. Fuller's letter said. "It is such a grand opportunity to save this area in its natural state that we hope that restoration rather than destruction may be the final plan."

"Undoubtedly this area in fine residential and park sites would in the long run prove far more remunerative to all concerned than to try to drain it and put factories where inundations may forever menace them."

"South of the Bixby Slough part lies the expensive Rolling Hills Estates, while several fine boulevards bisect the lands so that any improvement in appearance would be to the advantage of all, besides allowing the drainage problem to remain natural instead of trying to fight nature with artificial drainage devices."

State Jobless Payments Will Begin After Jan. 1

The California Unemployment Reserves Commission has established definite procedure for payment of unemployed compensation after Jan. 1. Estimates reveal the number of weekly checks to be issued will be as high as 50,000 for several months. Procedure as outlined by the Commission follows:

Immediately following registration of an unemployed worker at an office of the California State—Employment—Service, he begins his waiting period of four weeks required under terms of the Unemployment Reserves Act. The fifth week will be the first compensable week. The law requires certification by the unemployed worker to the effect that he has earned no money during the fifth week.

To that end, the Commission in complying with the law, will find it necessary to obtain certification before the actual check is made out; consequently, a sixth or seventh week to make certification and to allow the orderly functioning of administrative procedure will be required before the worker actually receives his first benefit check through the mail.

However, this procedure will not penalize the worker, regardless of when he gains new employment, all benefit checks due following the four weeks waiting period will be delivered to him by the Unemployment Reserves Commission.

For example: The waiting period required under the California Act is four weeks. The fifth week is a compensable week. In other words, a man goes on the Unemployment Reserve Commission's payroll beginning Monday of the fifth week. Should he fail to secure employment during any portion of the fifth week then he would be entitled to one week's compensation. It will be impossible, because of the large number of checks which must be paid, for the Commission to pay the fifth week's benefits to the employee until some time during the sixth or seventh week. If, however, the employee secures a position during the sixth week he will still receive his check for benefits for the fifth week regardless of the fact that he was employed in the sixth week. Similar conditions would prevail thereafter.

This procedure, Matthews said, will not only allow time for necessary procedural activities in mass production of unemployment compensation checks, but also will give the worker opportunity to have cash in his pocket before he receives a week's pay from his new employer.
