**CITY COUNCIL HIGHLIGHTS . . .**

**NO RETURNS . . .** were reported by the Tidewater Associated Oil company to City Clerk A. H. Bartlett from the use of the pipeline here during the past 12 months.

**NEW ELIGIBILITY . . .** list is now ready, the Civil Service commission of the city informed the council thru its secretary, Leroy Stevens. Examinations were held Nov. 6 for five different grades in the police and fire departments.

**LEFT TURNS . . .** should be discouraged by legislation and strict police supervision in order to cut the number of motor accidents caused by left-turners, the Auto Club of Southern California informed the council. Because Torrance city streets even at peak hours, are not congested, the advice was filed for future reference.

**DAMAGED LIGHT . . .** standard at 222nd and Cabrillo, for which a local resident is charged in police court here, will be repaired by the city at a cost of about \$150, according to a report made by City Engineer Frank Leonard. A previous estimate of the cost given police

officers quoted \$250 as the expense.

**STREET DRAINAGE . . .** facilities at Carson and Border avenues are to be improved by the city street department under direction of the city engineer and with the consent of the Pacific Electric at a cost of \$365.

**MASTER ZONING . . .** ordinance is ready, City Engineer Leonard told the council. But the city board decided to withhold action on this important civic piece of legislation until after the start of 1938. Public hearings are to be held on it.

**MUNICIPAL WATER . . .** report read by Councilman Robert Doeringer. It showed that for the past five months expenses totalled \$16,819, including the interest on the Municipal Water bonds at the rate of \$1,410 per month, while revenue was \$21,416, leaving a balance of \$4,595.

**NEXT MEETING . . .** of the council will be an adjourned session Monday afternoon, Dec. 20, at 4:45 o'clock. The next regular meeting is scheduled Tuesday evening, Dec. 28, at 7:45 o'clock.

**10,108 Scouts Ready to Do "Good Turns"**

In case of disaster or emergency calling for organized assistance, Los Angeles could count on the immediate aid of 10,108 registered Boy Scouts trained and skilled in first aid work. Edward B. DeGroot, Scout Executive, called attention to this fact in his report at the annual meeting of the Council last Friday.

"On December 1, 1937, there were 10,108 registered Scouts, Sea Scouts and Cubs in the local Council," DeGroot said. "There were also in the Council 2,541 registered adult volunteer leaders serving in various capacities as Board members, Troop Committeemen, Scoutmasters, Assistant Scoutmasters, Sea Scout leaders, Cubbers and Merit Badge Counsellors, making a grand total in registered membership of 12,649."

"One of the notable achievements of the Boy Scouts in their civic good turn interest and practice—their willingness to act as a body of minute men in response to the calls for the community 'help out' in all sorts of community enterprises. Up to December 1 of this year, 4,000 Scouts performed 20,000 hours of good turn civic service, not for pay, but for the glow of doing hard and helpful things cheerfully."

**Lomita Realtor to Seek G. O. P. Congress Bid**

When H. Lee Monroe, Lomita realtor, returns from an extended visit in Washington and New York next year, he will announce his candidacy for the Republican nomination as Congressman from the 17th district. Monroe, who is 16 years old, plans to leave for the east tomorrow.

"My formal announcement of my candidacy will include a review of my stand on problems which must be met by the national government," he is quoted as saying. He said that he is interested in old age pensions and "harmony between labor and capital."

**JAMES CARLIN SUCCUMBS AT HOME FRIDAY**

James Carlin, popular millwright foreman in the engineering and maintenance department of the Columbia Steel plant, succumbed last Friday night following a heart attack while he was at work the preceding Tuesday. He passed away, at the age of 55 years, at his home, 1019 Amapola avenue.

Mr. Carlin, who had lived in this city for the past 19 years, held but three jobs during his lifetime—a record few men equal and highly indicative of his steady and capable services. He was born in Nova Scotia, Canada and his first position was with the Dominion Iron and Steel company where he was employed until 1919.

**Had Six Children**

Then he came to Torrance and obtained a position with the Union Tool company (later the National Supply company) and remained with that firm until 1924 when he joined the Columbia Steel. He was survived by his devoted wife, Korena, and six children, Mrs. Marie Schmidt, James, Patricia, Korena, Ramona and Ellen; two cousins, Mrs. Arthur Mullin of this city and Miss Elizabeth Carlin of Hollywood.

Requiem mass was sung in his honor Monday morning by Rev. Father Joseph V. Fitzgerald at the Catholic Church of the Nativity and entombment was at Calvary Mausoleum. Stone and Myers were in charge of the funeral arrangements.




