Crash Fatal to Miss Garvey

Summoned to Tucson, Arizona, by the tragic death of her niece, Miss Annette Garvey, Mrs. Harritt Leach left Monday evening to attend the funeral. Miss Garvey was killed in an automobile accident New Year's Eve while driving from Phoenix to Tucson. A blowout caused her car to swerve into another machine, resulting in her fatal injuries and serious injuries to the four occupants of the other auto.

Miss Garvey assisted Mrs. Leach in the operation of the latter's florist shop here for about a year after it was opened and she had a great many friends in this community. She was 28 years of age.

License Renewal Period Will End On February 4

Motor license notification postcards, sent to every motor-car owner in the state, carry instructions for renewing automobile registrations and specify the fee to be paid. The license renewal period will end Feb. 4 with unregistered cars subject to penalties after the closing date of the period.

Howard E. Deems, registrar of motor vehicles, says every automobile owner should bring his post card notice with him when he makes application for his 1938 license plates. The 1937 registration certificate also must be exhibited at the time the new license application is made.

Use of Liquor Fees Limited to Enforcement

Cities and counties in California are expected to use the money they receive as their share of state liquor license fees to carry out the duties imposed on them by the newly-enacted section of the Alcoholic Beverage Control Act. This statement of policy was conveyed to the board of supervisors this week by the state board of equalization.

Los Angeles county recently received \$38,623 as its share of the license fees collected in unincorporated territory of the county for the first half of 1937. Cities of the county also have received sums varying from a few hundred and a few thousand dollars to the \$247,985 returned to Los Angeles.

Art Gallery Given U.S.C.

Accident Victim Seeks \$50,000 For Injuries

Damages totaling more than \$50,000 are sought for serious injuries received in the Torrance plant of the National Supply Company Jan. 9, 1937, in a complaint on file today in Los Angeles county superior court. Frank Gibson, the injured man, alleges that the company and James O. Bishop, master mechanic, were negligent in permitting a scaffolding to be erected in such a manner that it collapsed, causing Gibson to fall to the floor of the machine shop building.

Unable to work since then, Gibson asks reimbursement for lost earnings, for doctor bills and for disability, which he alleges is permanent.

Legion Medals Here for Award

The two large bronze medals and accompanying certificates which are to be presented to the graduating Junior high school boy and girl who top others of their class for leadership, citizenship and scholastic attainment by the American Legion and Auxiliary units of Torrance have been received. Juvenile Delinquency Report Is Filed

A total of 4,776 children were admitted to Juvenile Hall county school for minor delinquents, during the past fiscal year, according to the annual report of the institution.

Twenty-nine hundred of these children were boys and 1,876 girls, the report shows. Of the total, 3,737 were first offenders, 750 second, 202 third, 60 fourth, 19 fifth, 6 sixth and 2 seventh.

CALIFORNIA Looks Forward to 1938 And Backward to 1937

FISCAL OUTLOOK... California greeted 1938 with a bright fiscal outlook which state officials predict will carry the state out of the red within six months. Nearest estimates of the state's cash deficit as the old year drew to a close showed \$24,300,000 in debts still to be wiped from the books before the Merriam administration can go before the voters and cite a balanced budget as a potent argument for returning incumbents to office.

The \$24,300,000 figure is considerably larger than the \$11,198,261 general fund cash deficiency reported by State Controller Harry B. Riley in his report of Nov. 30. These figures show that the deficit increased more than \$13,000,000 during December.

WATER PROJECTS... Water and soil conservation projects for Central and Southern California totaling \$28,187,620 have been adopted by the State Planning Commission for submission to the National Resources committee in Washington. The projects included: Nigger Slough flood control project, \$2,615,500; Hawthorne drainage system, \$2,233,750; East Compton creek drain system, to serve South Gate, Lomewood and Compton, \$3,107,750; Los Angeles city storm drain, \$80,570,000.

County T. B. Death Rate In Big Drop

The death rate from tuberculosis in Los Angeles county dropped from 215.6 per 100,000 population in 1914 to 66 in 1935, a decline of 69 percent, according to a survey just completed for the county supervisors.
