Lomita Sidewalk Job Under Way

Construction was scheduled to get under way this week on curbs and sidewalks on 26th street between Cayuga avenue and Appian Way in Lomita. The contract was recently awarded by the board of supervisors to Vido Kovacevich on his low bid of \$2,256.50.

The work will include excavation of several hundred yards of dirt and construction of 1,835 feet of curbs and 9,000 square feet of sidewalk. It is the first of a series of proposed street improvements in Lomita and was the first to qualify under petitions circulated there.

Will Permit Route Thru to Highway

First step toward realization of the four-point highway program suggested by Mayor William H. Tolson by a committee of representative local citizens Feb. 1 was taken at city council meeting Tuesday night. On Mayor Tolson's motion the council approved securing an option with the heirs of the Kettler Estate for the extension of Cabrillo avenue to Eshelman avenue.

This option will enable the city to purchase something over two acres from the Kettler Estate at \$1,500 per acre, any time within a year. There was no consideration given for the option.

If the land is purchased, it will give the city right-of-way for a direct route from Western avenue, directly thru the business district along Cabrillo to U. S. Highway 101.

Other Pending Projects
Other proposed highway improvements endorsed by the citizens' group are: (1) Extension and improvement of Crenshaw boulevard (C. O. A. A. 100th street) to connect with the roadway at Redondo Beach boulevard; (2) Repavement of Torrance boulevard from curb to curb, eliminating the present center strip between El Prado and Date street; and (3) Re-surfacing of Hawthorne boulevard thru Walteria and up the hill to the Palos Verdes Estates.

Application of the Richfield Oil company for permission to abandon a pipeline on the south side of Sepulveda, from near Cedar to the southeasterly city limits was granted. The line was originally laid in 1922 by the Pan-American Oil company, later acquired by Richfield.

The picture selected is "The Cellist," recently exhibited in the Los Angeles Museum. It portrays Frode Dann, a Danish artist, performing on his cello. Dann is a personal friend of Miss Skeele and was one of her assistants in the execution of the high school mural, according to Miss Ada Chase, art director at the school.

"Mr. Dann has visited here a number of times and last year kindly loaned the school several of his fine water color paintings," Miss Chase said.

FAIR ROUTE OUTLINED

Southern Californians who plan to drive to the Golden Gate International Exposition will have an opens next Saturday will reach the man-made Treasure Island over a highway system as modern as the Bay bridge, itself. By means of a variation of the modern "clover leaf" design, motorists from either San Francisco or Oakland will be able to enter the Exposition grounds without making a left turn across intersecting traffic streams.


A parking lot for 32,000 cars and fully equipped service stations have been provided on Treasure Island. Warning signs, at each end of the bridge, will flash on when the parking lot is filled. A single bridge toll permits the motorist to visit the Exposition and return to his starting point or continue to the other side of the bay without extra cost.

Three of the Exposition traffic lanes are of permanent construction. The remaining three lanes are of temporary construction. Nearly a hundred highway signs have been erected on the new system to guide motorists.

Motorists Urged to Protest Proposed Jump in Gas Tax

Those least able to pay who use cars in their work would feel the pinch the most if the state gasoline tax is increased one cent a gallon, Jack Kemp, local manager of the Automobile Club of Southern California asserted today.

"They would cease driving or limit their car operation to such an extent that the very aim of the bill before the Legislature, which is to swell state highway revenues, would be defeated," he declared.

The club is inviting motorists to write letters of protest to the organization for use in the fight against the threatening measure introduced by Senator Biggar of Mendocino County. A huge volume of communications already has been received, expressing motorists' opposition in vigorous terms, Kemp said.

The motorist buying lower grades of gas at 16 cents a gallon pays a 3 1/2 percent tax in the 4-cent levy, he pointed out. If the attempt to raise this to 5 cents a gallon succeeds, his tax

Western Avenue Extension Is Being Revived

After years of more or less intensive effort failed to bring results, the Harbor District Chambers of Commerce is again pressing the long-proposed extension of Western avenue thru the undeveloped section between its present terminus here and Highway 101.

The Harbor booster association decided last Thursday night at Bellflower to sanction a meeting of Torrance, Lomita, Harbor City and San Pedro Chambers of Commerce representatives to confer with Supervisor Oscar Haugse on the project.

The meeting is to be arranged by Secretary L. J. Gilmeister of the local chamber. The Western avenue project was given the "right-of-way" on the list of Harbor Chambers' activities. The association also voted to support another long standing plan—that of widening Lomita boulevard between Lomita and Harbor City.

An open meeting of the Harbor affiliation of chambers of Commerce, sponsored by its legislative committee, was held Tuesday at Gardena. Various state legislators were present to explain bills pending before the legislature.

Hagerstrom Wins Another Delay In Morals Case

Another continuance was granted Charles Hagerstrom, Hollywood film laboratory worker, Tuesday morning by Judge Kauffman of the Compton justice court, when he appeared for trial on charges of indecent exposure, lewd vagrancy and driving while intoxicated. Hagerstrom, who was arrested at his Hollywood home Jan. 24 by local police after assertedly committing the offenses before three local school children, had obtained a change of venue from the city court here to the Compton court last week.

He again pleaded not guilty to all three accusations but waived his previous demand for a jury trial and informed Judge Kauffman, thru his attorney, that he will be content with a court hearing of his case. This was set for next Tuesday morning, Feb. 21. Hagerstrom continued at liberty on \$1,000 bail.
