

Civic Groups Asked to Back Park Plan



LOS ANGELES

A rare opportunity is presented to the County of Los Angeles to secure, without undue expense, approximately 1800 acres of the famous Palos Verdes peninsula, as a magnificent county park. The proposed park includes the entire crest of the hills, as well as a splendid beach frontage. It affords every opportunity for all types of recreational development and with a steady program of planting and landscaping, will become an incomparable beauty spot and world famous.

The Los Angeles County Parks Committee invites every citizen to become a member and to assist in the working out of this fine community enterprise.

P. V. SITE IDEAL FOR RECREATION

A project of major importance to this area has been proposed by a committee of civic-minded Southland residents which would create a splendid sea-girt recreational park in the Palos Verdes Estates for the enjoyment of all citizens of Los Angeles county. The above map and legend shows the site and size of this potential development which is shortly to come before the Chambers of Commerce and other civic organizations of the harbor district for their approval.

Next Tuesday Isadore B. Dockweiler, chairman of the Los Angeles County Parks Committee will hold a luncheon meeting at the California Club for all committee members and invited guests to stimulate development of the project. Among the local guests will be Mayor William H. Tolson, Grover C. Whyte and R. R. Smith.

Dockweiler says: "If satisfactory arrangements can be worked out—and I think they can—our committee feels that the Palos Verdes proposal presents a rare opportunity to create a great community asset and, in the years to come, a world famous beauty spot."

Located back of the Miraltes school and extending from the Palos Verdes reservoir of the Metropolitan Water District to the ocean, the site is "right next door" to Torrance and Lomita. Residents of this district have acclaimed the project as being of inestimable benefit to the two communities, Harbor City and Waverly as well as the port cities.

President R. R. Smith of the Torrance chamber, is expected to head the local committee to promote the county park development and he will present the project at the next chamber meeting. It is planned to obtain this site of 1,800 acres of rolling terrain and a 2,000-foot ocean frontage at very little expense to taxpayers.

Most of the property within the county park site is encumbered by delinquent taxes and is due to be sold to the state next year by tax-deed. It is believed by the Los Angeles county parks committee that the county can obtain title to this land at small expense. Then it can be developed by the C. C. C., or thru the state and county forestry department. The county would maintain the park facilities.

The large site is especially adapted for recreation uses and could house a Boy Scout camp that would serve the entire county. E. C. Porter is executive secretary of the organization backing this plan and it is being supported by many county civic groups already.

The injured were: Vernon C. Hunt, broken left leg and bruised right leg; Mrs. Parsen who received emergency treatment at Torrance Memorial hospital for deep lacerations on her forehead and then was taken to a Santa Monica hospital; Ben Sandefur, who was given emergency treatment at the Torrance hospital for five broken ribs, a bruised collar bone and a fractured left shoulder, was later removed to the county hospital, and Mrs. Luella Sandefur, who was thrown out of her husband's car, landed on the pavement but escaped with only a bad bump on her forehead. She suffered other contusions about her body, however.

After obtaining statements at the scene of the multiple collision and checking the registration of the abandoned car, police arrested William Naess, 42, Monte E. Boyd, 51, San Pedro, and Ted Kiso, 28, 1924 Highway 101, Lomita, at their homes on suspicion of hit-and-run and drunk-driving.

Later Naess and Kiso, both longshoremen, were released. Police Chief Stroh said it had been definitely determined they were not implicated in the collision. But Boyd, also a longshoreman, was held and felony charge of drunk driving was placed against him.

Boyd will be given a preliminary hearing before City Judge Robert Lessing Monday morning, April 15.

that the main trunk line leading into the West Torrance section will stop at Torrance boulevard and Crenshaw. However, it will be of sufficient capacity and deep enough to serve areas up to 800 feet north of Torrance boulevard between Crenshaw and Maple street whenever it is desired to put lateral extensions in that section.

When Mayor Tolson reported these details to the city council last night, City Engineer Leonard Young advised a careful study of the entire subject, pointing out that Sanitation Districts may now institute improvements under a new law. The matter was referred to Young and City Attorney John E. McCall for investigation and report.
