This verse from the Psalms, "Teach me to do thy will; for thou art my God; thy spirit is good; lead me into the land of uprightness," is the Golden Text in the Lesson-Sermon on "Spirit on Sunday in all Churches of Christ, Scientist."  
A Scriptural selection presents these passages from John: "Now there is at Jerusalem by the sheep market a pool, ... And a certain man was there, which had an infirmity thirty and eight years. When Jesus saw him lie, and knew that he had been now a long time in that case, he saith unto him, Will thou be made whole? The impotent man answered him, Sir, I have no man, when the water is troubled, to put me into the pool; but while I am coming, another steppeth down before me. ## San Pedran Maps Campaign for State Assembly Candidacy

Altho the adjourned session was called for the express purpose of fixing the 1940-41 municipal tax rate, the city council was unable to adopt the levy ordinance Tuesday afternoon because the final figures on the city's assessed valuation were not available. City Clerk A. H. Bartlett announced that he had received word shortly before the session began that the valuation total would be sent here Aug. 12. The council will adopt the new tax rate at its regular session on the night of Aug. 13.

Mayor Tom McGuire, having returned from his vacation, presided over the Tuesday afternoon meeting at which the following business was transacted:  
A request for payment of an increased membership fee in the Southwest District Highway Association was filed for future reference, the council indicating further information will be sought on the activities of this organization and its value to Torrance.

The Metropolitan Water District was informed that the city does not desire to pay any portion of the regular M.W.D. tax out of its general fund and the tax will therefore be collected in full as usual—by the county tax collector from local property owners.  
Because he has leased his Southern Hotel and the city license is not transferable, Edward L. Guth asked the council for a refund on his recently-paid license of \$12. The request was granted.

A report was received from City Attorney McCall that the Asbury Rapid Transit Company, which is leasing some of its buses to Torrance for the municipal bus system, in Los Angeles, has requested the State Railroad Commission to hold its order pertaining to regulation of the company in abeyance until further negotiations can be made with the city of Gardena relative to coordination of the Torrance and Gardena Lines.

In connection with the bus matter, the council was informed that the State Board of Equalization expects to collect a fee of three percent on business transacted in territory outside of city limits. No action was taken on this notice.  
A suggestion form for a city ordinance prohibiting trespass as a national defense safeguard was received from the California League of Municipalities. It was given to the Ordinance committee, headed by Councilman Vern Babcock, for study and recommendation.

Bids on the purchase of a large quantity of pipe and other materials to be used in connecting this city's mains with the M.W.D. system will be opened at a special meeting of the council at 5 p. m., Aug. 20.  
An appropriation of \$270 for new swings and slides at the Walteria and city park playgrounds was approved. Other appropriations were made for materials to improve local streets and alleys and to buy new material for the municipal water department.

The two weeks series of revival services which have been in progress at the Torrance Men's Bible Class building, under direction of Rev. Martin S. Charles Mundell of Inglewood, will come to a close with a special rally and mass-meeting Sunday afternoon at 2:30. There will be no morning or evening service on the closing day.  
A special service and program has been arranged for tonight, Friday and Saturday nights, and for Sunday afternoon. Rev. Norman Parsons of the Los Angeles Bible Institute will assist Rev. Mundell in the service tonight and will show actual motion pictures of the war now raging in Europe.

Friday night Rev. Mundell will draw upon his experiences as a vaudeville magician to illustrate and demonstrate an exposure of fake mindreaders, fortune-tellers and astrologers. Saturday night's service will continue the exhibitions and demonstrations of Friday night, and on Sunday afternoon Rev. Mundell will give his personal testimony of conversion from atheism.

## College Group Asks County for Alondra Park Site



Preparations to wage an aggressive campaign in Torrance in behalf of his candidacy for Assemblyman from the 68th Assembly district on the Democratic primary ticket were announced today by Cornelius J. McGovern, San Pedro attorney and World War veteran.

McGovern says he is familiar with labor, economic and business problems of the 68th Assembly district and feels that he is able and qualified to give the district the representation that it is entitled to as the largest port on the West Coast.  
McGovern was born in Colorado and is a graduate of the University of Colorado law school. He has practiced law in Los Angeles county for the past 11 years, coming here from Pueblo, Colorado, home of the Colorado Fuel and Iron company's steel plant. He was employed at this plant prior to entering U. S. Army in 1917. For six months prior to June 15 he was a trial examiner for the Contractors' State License Board.

## Navy Seeks College Men for Reserve; Chamber Has Full Information

The U. S. Navy is recruiting a total of 5,000 American-born college men to be trained for commissions as Ensigns in the U. S. Naval Reserve. Letters have been addressed to all college men in the 11th Naval District (which includes Southern California) whose names and addresses could be secured to give them complete information on the Navy opportunity.  
Similar data has been sent the Torrance Chamber of Commerce where any college man interested in joining the Reserve may obtain full information. The second Cruise is scheduled for Aug. 19 so prompt attention is necessary to qualify.

## Clerk Job Open In Township Justice Court

A civil service examination is to be given to select an assistant clerk for Inglewood justice court, it was announced this week, with August 21 as the last day to file applications to take the test.  
Salary is \$100 a month to start, with \$120 a month as the highest salary. Candidates must be electors of Inglewood township, and must present their registration receipt. Applicants must be 21 years old but not more than 55. Good all-around clerical ability is required, knowledge of typing, and a full high school course or its equivalent.

## College Group Asks County for Alondra Park Site

An offer to take over the 300-acre Alondra county park and "proceed to develop it as an educational and recreational park of cultural significance" was pending before the board of supervisors today, made by the Collegial Foundation, a non-profit California corporation at Orange.

Leon Patrick, secretary to the board of governors, said their proposition "would relieve the county of further care and expense for the park, and permit the foundation to serve the people in a recreational center of cultural appeal." He said he had inspected the park and had conferred with Supervisor Oscar Hauge on one occasion.

Buildings would be erected for administrative purposes, and recreational and game plots laid out. He asked for a personal conference with the entire board to explain his proposal in greater detail.  
County Counsel J. H. O'Connor was asked to report as to the legality of the proposal before any further steps are taken. Beyond the rather indefinite statements made in Patrick's letter, no further information could be gained from county officials.

A further step in the refunding of the outstanding bonds against property in the old Mattoon Act district formed for the acquisition of Alondra Park was taken Tuesday when the supervisors adopted a resolution finding that the refunding was in the public interest.  
Bondholders are asked, as the next step, to place the remainder of their bonds in irrevocable escrow with a Los Angeles bank, and the county will arrange to purchase them at par plus interest, with an allocation of \$309,730 set up.

## Retail Store Sales Show Gain; Local Shops Up 7 percent

Sales of independent retail stores in California for the first six months of 1940 were 3.9 percent higher than during the same period of 1939. The U. S. bureau of the census reported today.  
For the city of Torrance, sales showed a 6.9 percent increase as compared with 1939.

Among cities of the state over 2500 population, Santa Monica had the largest increase in retail sales, gaining 19.1 percent over the six-month period last year. San Diego was next with an increase of 15.5 percent and Santa Ana third with 14.3 percent.  
Los Angeles had a gain of 3.8 percent; San Francisco, 1.5 percent; Oakland, 1.3 percent, and Long Beach, 4.5 percent.
