

Mrs. Cucci Named on Dem. State Central Committee

Dr. George Lancaster Passes State Board

Dr. George Lancaster, son of Mrs. J. S. Lancaster of this city, passed his state medical board examination this week. He is a graduate of the College of Medicine at U. S. C., who served his internship at the Los Angeles county hospital. For the past several months he has been a resident physician at Huntington Memorial hospital in Pasadena. Dr. Lancaster's father, the late Dr. J. S. Lancaster, who succumbed Nov. 5, 1938, was a physician and surgeon for 27 years.

Two Industrial Projects 'Boom' Harbor District

Industrial prospects of the harbor district adjacent to Torrance, Lomita and Harbor City spurred to boomtime proportions during the past week with announcement of two major developments.

Howard Hughes, wealthy sportsman, film producer and famed aviator, was reported completing a deal for the purchase of 16 acres of land at the southwest corner of Sepulveda boulevard and Main street upon which will be erected an airplane parts manufacturing plant at a cost of approximately \$1,500,000 as the initial investment.

The Navy department Monday awarded a contract to the Los Angeles Shipbuilding & Drydock Corporation for a repair ship to cost approximately \$16,000,000 and to Bethlehem shipyard in San Pedro contracts for six destroyers at \$8,100,000 each. The total is more than \$84,000,000 worth of shipbuilding for San Pedro with jobs for several thousand men in prospect.

Preliminary plans for Hughes' airplane parts plant call for erection of two modern factory buildings 600 and 400 feet in length. Actual construction is expected to be under way within 60 days. It was estimated that between 1,500 and 2,000 men will be employed in the new factory when machinery is installed and ready for operation.

News of the Navy contracts was received joyfully by Harbor District civic leaders who hailed the reports as "only the beginning of Los Angeles harbor's share in the huge national defense output. Already the Navy had allocated more than \$19,000,000 for improvements on Terminal Island. It is understood that the port shippers will be able to begin construction of the repair ship as soon as necessary steel starts arriving.

Douglas Plans Complete Forty plant design engineers for several weeks have been detached from the 1400 on the Santa Monica plant's staff, and housed in quarters away from the factory by themselves working day and night on the Long Beach plans.

The plant will have double the capacity of the Santa Monica plant, which this week had 18,700 men at work. Officials state in full operation the plant would employ far in excess of the 20,000 heretofore mentioned.

George Stromple, factory manager at the Santa Monica plant, has been assigned as manager of the Long Beach plant. His assistant will be R. E. Houghton, now chief engineer of the Santa Monica plant.

City Workers Who Enter U. S. Service May Have Their Jobs on Return

If a proposal made by Councilman George V. Powell at Tuesday night's city council session is adopted, any municipal employee who is called for military duty will resume his former status with the city on his return from such service.

City Attorney John E. McCall was asked to investigate and find out what other cities are planning to do for their workers who may join the national guard, Army, Navy or Marine Corps and then to draft a resolution to comply with Powell's suggestion.

Mayor Tom McGuire reported that the National Supply Company proposes to pay its employees who enter military service the difference between their service pay and what they would have made if they continued in the employ of the company. He said that no length of time for such extra remuneration has been determined as yet.

More Vocational Training Sought by Jr. Chamber

A request that the state department of education and the Los Angeles Board of Education establish facilities for training students in skilled crafts essential to national defense was made last Thursday night by the Torrance Junior Chamber of Commerce in a resolution sent to those educational groups and the U. S. Office of Education.

The Junior Chamber noted that the state department of education is now setting up classes in connection with established training facilities in the public school system and that no such classes have been set up in the highly industrialized area of Torrance. "Probably because of the lack of adequate training facilities," the resolution states and continues: "Hundreds of young men residing in this area comply with the provisions of the program and are available and anxious for vocational training... this offered."

The Junior Chamber authorized President John Elder to appoint a committee to investigate the possibility of establishing an air field in Torrance, believing that if such a field were available here the city could stand a much better chance of obtaining new industries allied with aircraft production.

Supply Workers Asked to Record Citizenship

All employees of the National Supply Company here have been asked to supply documentary evidence acceptable to the government for the purpose of establishing their American citizenship. Notices sent out to the workers recently pointed out that this was essential because the company may manufacture materials for the U. S. War Department under the national defense program.

Birth records, certified copies of baptismal or other church records showing age or date of birth, family records, statements of practicing physicians attending births, reports of the census bureau or other documents qualify for this information, the company stated.
