NOTED STEEL EXPERT TO VISIT HERE

Raymond K. Bowden, manager of the metallurgical division, Chicago District, Carnegie-Illinois Steel Corp., will be a visitor at Columbia Steel Company here this week, according to John Disario, metallurgist of the local plant.

Bowden will be here to deliver a lecture on "The Role of the Metallurgist in Production and Use of Alloy Steels," at the Western Metal Congress, May 19-23 in Biltmore hotel and Pan-Pacific auditorium, Los Angeles. He is programmed to speak Wednesday afternoon in the auditorium. In announcing Bowden's coming to Torrance, Disario said the Congress will go far in inspiring finer metals for national defense and aid to Britain. He said top flight research physicists, metallurgical engineers and scientists of the steel industry from all parts of the country will deliver lectures.

The sessions are open to all men of the metal industries. Fifty thousand are expected to go through the exhibits in the auditorium, and 3,000 are expected to be seated at the technical sessions, which will be presented by the American Society for Metals, American Welding Society and American Foundryman's Association.

Disario is a member of the former society, and has been active as a committeeman in making arrangements for the event. He has been drafted to act as chairman for the metals society's technical sessions on the evening of May 20.

Will Curtail Service at Torrance Branch of Justice Court

Justice courts in the 24 townships of Los Angeles county will cost \$223,783 to operate next fiscal year, or \$4,691 more than for the present year, according to the preliminary budget submitted to the board of supervisors by Wayne Allen, their chief officer.

Part of the increase is due to an additional half-time clerk in 23 Monte justice court, where traffic cases and traffic fines have shown a decided upward trend, according to Allen's statement accompanying his budget recommendations.

In the Torrance branch of Inglewood justice court one half-time clerk is to be discontinued beginning July 1, on Allen's recommendation. The Torrance branch carries a light work load, and elimination of the clerk half-time will not inconvenience litigants because both the Gardena and Redondo branches are near by, Allen added.

Future Farmers In Contests Show How Their Training Pays

Members of Torrance high school's Future Farmers went to the Voorhis unit of the California Polytechnic School at San Dimas last Saturday. Bob Schwartz placed second in both plant and flower identification contests held at the open house event. At Voorhis, training is given to prepare young men for state and county agricultural inspection work. Joe Bay, Torrance high graduate, has completed work there and is now engaged in pest control work for the state.

On April 19 a team represented the Torrance Future Farmers at Newport Harbor's poultry field day. In the open section, Don Thompson stood high man in judging meat birds. These contests stimulate interest in knowing what to look for in good livestock or plant materials and give practice in choosing desirable plants and animals, according to Harry H. Stone, instructor at the high school.

Thomas Proposes State Commission for S. P. Harbor

Creation of a three member harbor commission to operate the San Pedro Harbor under state control is being sought in the state Legislature by Assemblyman Vincent Thomas, San Pedro Democrat.

Thomas proposed to authorize the issuance of revenue bonds so that the west portion of the Los Angeles Harbor may be developed by the state.

"The city of San Pedro," Thomas said, "annexed itself to Los Angeles in 1909 and at that time promises were made that improvements would be made in the west side of the harbor. Since the city of Los Angeles has not fulfilled its promises we propose to transfer our harbor to the state of California so that no longer will we be handicapped."

Coordinators Seek Dance Concessions

Three requests from the Torrance Coordinating Council pertaining to the student dances in the Civic Auditorium Friday nights were read before city council meeting Tuesday night. The first was that the city install a gate between the Auditorium and Chamber of Commerce building to permit that intervening space to be used for "cooling off" between dances. The Coordinators, said Mrs. Flora B. Wright, secretary, did not want to issue "pass-out" checks and allow the student dancers out of the building during dances but the ventilation was very poor and some relief should be provided.

The city engineer and fire chief were instructed to investigate and determine if a gate would be safe.

The next two requests were for cancellation of the rental fee (\$20 per night) charged for the last two student dances, because a deficit was incurred. The Coordinators were taking advantage of the council's offer on April 10 to cancel the rental whenever the Coordinators fail to make expenses on the dances.

No action was taken on these requests, Mayor Tom McGuire suggesting that Vernon Coll, manager of the dances, be asked to submit another financial report.
