

Distinguished Unit Badge for Sergeant Page

Staff Sergeant Wilson R. Page, Torrance, Calif., is now authorized to wear the Distinguished Unit Badge, signifying that he is a member of a Twelfth Air Force B-25 Mitchell bombardment group at Corsica which has received the War Department citation "for its part in destroying the Benevento, Italy, marshalling yards with devastating effect."

The citation reads in part: "Distinguishing themselves through extraordinary heroism and unswerving resolution, the combat crews destroyed 18 of the attacking planes and bombed the marshalling yards with devastating effect. The gallantry and combat proficiency exhibited by the personnel of this group in striking this decisive blow have reflected the highest credit on their organization and the military service of the United States."

Joining his present group 24 months ago, Sergeant Page is serving as an administrative clerk.

His parents, Mr. and Mrs. W. Rufus Page, reside on Arlington ave. in Torrance.
