City Court Fines \$1,888 For Month

From February 1 to and including February 28, 1945, the City Court of the City of Torrance received \$1888 net from fines and fees, according to report of City Judge Otto B. Willett. Of this sum \$817.50 are general fund monies, while \$1069.50 came from vehicle violations and thus are road fund monies.

General fund monies were collected from the following cases: drunkenness, \$442.50; parking, \$39; boulevard stop, \$96 and miscellaneous criminal violations, \$240.

Vehicle code funds were derived from the following cases: drunk driving, \$370; speeding, \$316; and miscellaneous traffic violations, \$183.50.
