Furnishing all labor, transportation, materials, scaffolding, tools and equipment necessary for the construction of a recreation building 20ft. x 42ft. as per the plans and specifications. No bid will be accepted unless it is made on a proposal form furnished by the City Engineer. Each bid must be accompanied by cash, certified cashier's check, or bidder's bond, made payable to the City of Torrance for an amount equal to at least ten (10) per cent of the amount bid; such guaranty to be forfeited should the bidder to whom the contract is awarded fail to enter into the contract.

In accordance with the provisions of Section 11770 of the Labor Code, the City Council has ascertained the general prevailing scale of wages applicable to the work to be done, as follows:

FOREMEN All foremen not herein separately classified shall be paid not less than \$1.00 per day more than journeymen rate for the craft involved.

APPRENTICES May be employed in conformity with Section 11775 of the California Labor Code.

Sundays and Holidays: (except Watchmen, Guards, and Flagmen) One and one-half (1 1/2) times the above rates.

All bids are to be prepared on the basis of the City Engineer's estimate of work to be done.

No bid will be accepted from a contractor who has not been licensed in accordance with the provisions of Chapter 791, Statutes of 1929, as amended.

Plans, specifications, forms of proposal, and contract, may be obtained in the office of the City Engineer, City Hall, Torrance, California, on payment of \$1.00; refundable upon return in good condition.

The City Council reserves the right to reject any or all bids, or any item or items of any bid, and to take all bids under advisement for a period of not to exceed thirty (30) days after date of opening thereof.
