Jewelry Wage Scale Fixed In WLB Order

Employers in retail jewelry establishments in Los Angeles County may not hire workers at more than \$1.67 an hour for watchmakers, \$1.47 for senior salesmen, \$1.33 for jewelry repairmen and 83 cents for junior salesmen with the exception of employers whose rates for these classifications were higher prior to October 3, 1942, it was announced today by Thomas Fair Neblett, chairman of the Tenth Regional War Labor Board, following action taken by the Board in setting highest applicable hourly rates for the industry.

The rates were established, with labor members of the Board dissenting, on the basis of a survey made by the Bureau of Labor Statistics of the U. S. Department of Labor and are the highest the Board can approve in considering voluntary wage applications or settling labor-management disputes, Neblett stated.

Chairman Neblett explained that employers do not have automatic authority to adjust wages to the newly approved rates. If they wish to grant increases to the approvable limit, they must first obtain permission of the Board by filing a voluntary application known as a Form 10, with the Wage and Hour Division of the U. S. Department of Labor.

Service Men May Get More Gas On Furloughs

Servicemen who are granted furloughs longer than 30 days will be able to obtain more gasoline by a new ruling now in effect.

Such men, along with released American prisoners of war who get leave or temporary duty assignments for 60 days in this country, will be allowed a gallon of gasoline a day for as long as their furloughs or assignments last. Previously, furloughed servicemen were also given a gallon of gasoline per day but a limit of 30 days was placed on their eligibility.

Applicants for such rations should apply at their local ration board, bringing with them mileage rationing record for the car to be used and their furlough papers.

\$47.50 Average For L.A. County Property Levy

Local property tax levies in Los Angeles county averaged \$47.10 for each \$1000 of assessed valuation for 1944-45, the last completed fiscal year, California Taxpayers' association said today, making public its analysis of the property tax bill in California counties.

For 1943-44, local property tax levies in the county averaged \$46.50 per \$1000 of valuation; for 1942-43, they averaged \$47.20 per \$1000. County, city, school and special district levies are included.

The county is one of nine in California in which property taxes levied averaged between \$40 and \$50 per \$1000 of assessed value in 1944-45. Four California counties had levies which ranged between \$10 and \$20 per \$1000 of value; nineteen levied between \$20 and \$30 per \$1000; twenty-five were in the \$30 to \$40 per \$1000 range; nine levied between \$40 and \$50; in only one was the levy more than \$50 per \$1000 valuation.

Over the state as a whole, the local property tax levy per \$1000 of assessed value averaged \$49.90 for 1944-45, compared with \$39.70 for 1943-44 and \$41.10 for 1942-43.

"Preliminary local budget figures throughout the state indicate a considerable increase in local property taxes for 1945-46, unless action is taken to reduce local spending programs," the Taxpayers' association declared.

Rail Travel Restrictions Apply Here

Torrance and Lomita residents are advised of swiftly moving developments on the Pacific Coast transportation fronts which not only will speed up movements of men and materials, but also will impose greater transportation restrictions upon civilians until the crisis has passed.

Following Office of Defense Transportation orders to railroads prohibiting sale or allocation of passenger space more than five days in advance of train departures, and withdrawal of all sleeping cars operating between points 450 miles or less, ODT Director J. Monroe Johnson called upon commercial and industrial firms to help out by reducing travel of their officials and employees.

Meanwhile, the Pacific Coast Intercollegiate Athletic Conference has announced it would adopt a travel conservation program concurred in by colleges and schools throughout the country, which includes elimination of long trips and inter-sectional and post-seasonal games, limitation of ticket sales to local attendance and reduction of traveling team personnel.

4-8-8-4

Railroaders identify various types of locomotives by the number and arrangement of wheels from front to rear. The Union Pacific locomotive pictured above is known as a "4-8-8-4"... two pairs of small wheels in front, then four pairs of driving wheels followed by a similar unit, and two pairs of smaller wheels in the rear—not including the tender.

The "4-8-8-4" type is Union Pacific's largest and heaviest steam locomotive; informally christened "Big Boy" by the men who built it. This giant of the rails is 132 feet in length and weighs approximately 600 tons. Water

capacity is 25,000 gallons; fuel 28 tons. A fleet of 25 "Big Boys" is now in Union Pacific service. Built primarily to haul heavy freight loads on western mountain grades, they have proved invaluable in transporting tremendous quantities of war materials over the Strategic Middle Route, uniting the East with the West Coast.
