possible, and at some central point.

"2. Put the veteran in contact with the proper agency which can provide the RIGHT KIND of specific assistance, if it is not available at the central information point in the Veterans Memorial Building; and do so smoothly and speedily.

"3. Make available expert, sympathetic advice in each of the major fields in which veterans may want help.

"4. Make it easy to get help, since many of the most deserving veterans may be reluctant to ask for assistance.

"Through the liberal donations of industry, commerce and the citizens of Torrance and the Torrance area, an effective Veterans Information Center will be maintained and operated twenty-four hours a day, without cost to the veterans or to the community."
