Many officers of Parent-Teacher Association from Torrance and Lomita will attend the meeting of the Tenth District California Congress of Parent-Teachers to be held Thursday evening, Dec. 6, at 7:30 p.m., at Francis Polytechnic high school, 400 W. Washington blvd. The meeting is slated to be a teachers' institute meeting as well.

Dr. Vierling Kersey, superintendent of Los Angeles City Schools, will be present to welcome parents and teachers. Mrs. Edward W. Raith, district president, will preside. She will be assisted by Mrs. Harold H. Worth, second vice president, and Mrs. Robert Bogen, parent-teacher study bureau manager. Hostess councils are Exposition, Fremont, Gardena-Wilmington and Highlands.

The feature of the program will be an illustrated lecture by Professor William Fowler, of the department of physics, California Institute of Technology. Cost of Living 132 Percent More Than 1935

It doesn't cost a cent more to live here this month than last month. But the cost of living is still 132 per cent above the 1935-39 average.

Charles A. Roumasset, bureau of labor statistics economist, revealed late yesterday that the period Sept. 15 to Oct. 15 showed the same cost of living as the preceding 30 day period.

This was the first time in eight months the cost of living had not increased in a monthly survey.

Red Tokens Must Be Turned In, Says Government

All retailers, wholesalers and primary distributors of rationed meats and fats must turn all red tokens in their possession into their ration banks before Dec. 12, Paul Barksdale d'Orr, OPA district director said. Only the tokens must be turned in, d'Orr explained, and meat-fats ration stamps may be disposed of by the holders as they see fit.

Director d'Orr pointed out that the red tokens are government property and must be collected to prevent their misuse. Most of such tokens, he said, are held by the trade and, by ration banks, and, if surrendered promptly, the government agency will be enabled to rapidly wind up all matters pertaining to the terminated ration program.

The tokens need not be counted, d'Orr said, and may be placed either in the standard container or in a sealed envelope. Naturally, he pointed out, no ration credit will be given for surrendered tokens.

Wage Claims Policy in Trade Dispute Clarified by Employment Department

Election of officers for the next term was held at the last regular business meeting Friday evening.

Marion Spaan, retiring queen, will be the installing officer. Miss Dorothy Little is guardian of the Bethel and Earl Quesinberry, associate guardian.

After the impressive ceremonies, a reception will be held.

As a result of the increase in the number of trade disputes throughout the state, and their consequent effect on claims for unemployment insurance, general policy of the California Employment Stabilization Commission in handling these claims was reiterated Nov. 29 in a special memorandum to all field staff of the Department of Employment.

The memorandum, issued by James G. Bryant, chairman of the commission, follows:

The disqualification under Section 56 (a) of the act is imposed on claimants who "left their work because of a trade dispute." A claimant who becomes unemployed because of his participation in a trade dispute with his employer either by reason of direct strike action by his union or because of his failure or refusal to cross a picket line to return to work is disqualified from receiving benefits under this section.

This disqualification will continue for an indefinite period during which the claimant remains out of work by reason of the fact that the trade dispute is still in active progress in the establishment where he was employed.

The fact that a claimant subsequently elected to return to work and was unable to do so because of the stoppage of work at his employer's place of business, or because of physical restraint by a picket line which prevented his reporting for work, would not remove the trade dispute disqualification so as to render the claimant eligible for benefits, as long as the trade dispute is still in active progress in the establishment at which he was employed.

However, where a claimant has been locked out by his employer, he would not, under the decision of the State Supreme Court, be disqualified under Section 56(a). Similarly where a claimant has been discharged or laid off, the disqualification would not apply, as the claimant's unemployment would be attributable to the act of his employer and the claimant cannot be charged with leaving his work because of a trade dispute.
