So. California Over Top; City Bond Buying Lags

Southern California went over the top at the 11th hour and exceeded its Victory Loan quota by \$108,270,000 as unprecedented individual purchases last Saturday brought total sales for this area to \$432,270,000. These figures were compiled yesterday by the Federal Reserve Bank and dispelled fears that individual sales might not equal the quota set for the first time in eight War Bond campaigns. Instead, they totaled 103.2 per cent.

Southland individual buyers invested \$10,610,000 in Victory Bonds on the final day of the drive, to exceed their quota by \$4,840,000. Corporation purchases went over the top last Friday.

Robert H. Moulton, War Finance Committee chairman for Southern California, yesterday announced that all December sales of Series E, F and G bonds will be credited toward the Victory drive quota. Series E sales still fall short of the goal of \$81,000,000, Moulton said.
