CPA Tightens Lid On Commercial Construction, Will Aid Others

With the Civilian Production Administration clamping the lid tighter on commercial construction throughout the nation because of building material shortages, Louis M. Dreyfus, regional director here, today expressed reasonable assurance that details for the next 45 days will exceed approvals in dollar value due to the fact that approvals will be confined to the following:

1. Projects essential to public health and safety.
2. Projects which will increase production of critical materials.
3. Projects providing urgently needed veterans educational facilities.
4. Essential and non-deferrable maintenance and repairs.

Mr. Dreyfus' region includes the 12 Southern California counties of Los Angeles, San Diego, Imperial, Riverside, Orange, San Bernardino, Ventura, Santa Barbara, San Luis Obispo, Kern, Inyo and Mono, plus the states of Arizona and Utah.

While building material production was on the upswing before the spring wave of work stoppages and strikes, Dreyfus reported that the inventories have been severely depleted during the strike period.

As a result, Mr. Dreyfus added, the gap between supply and demand is widening.

The pre-strike upswing showed that March lumber production of 2.6 billion board feet rose 24 percent above February, which
