

# Right Guide

Questions received by "Right Guide" are no longer general in nature, but are genuine problems encountered in the individual application of some law.

Some of these questions have been selected because other veterans might be helped by the information contained in the answers.

**Question:** Is there any option of beneficiary payment offered in a National Service Life Insurance policy which cannot be changed by beneficiary after death of insured?

**Answer:** Yes. It is called, "Option No. 2." Under this option the first beneficiary receives payments for life.

**Question:** My husband was killed in World War II. I was named his beneficiary. Will I receive his insurance after I remarry?

**Answer:** Yes. Remarriage does not change, in any way, payments of NSLI to beneficiaries.

**QUESTION:** I am attending school under P. L. 346 (GI Bill). I have a part time selling job; does the amount of money I make on this job have anything to do with the amount of subsistence allowance I receive?

**Answer:** It does not. Subsistence allowance (if other procedures and requirements have been complied with) depends upon whether you are working full or part time. If you have a full time job in addition to school work you cannot receive subsistence allowance. Part time, yes. The amount you make has nothing to do with it.

**Question:** Does the amount of money I make on my job have a bearing on the amount of pension I may receive?

**Answer:** No. Pensions are not reduced because of sizeable incomes, nor increased because of small incomes. Pensions are based upon percentage of physical disability.

**Question:** Does a discharge "under conditions other than dishonorable" mean any kind of discharge except a dishonorable discharge?

**Answer:** No, it does not. An honorable discharge or a discharge under honorable conditions qualify a veteran for benefits under the Servicemen's Readjustment Act (GI Bill); a dishonorable discharge disqualifies him; but a discharge that is neither honorable or dishonorable may qualify him or disqualify him, depending upon the determination of the "conditions" under which he received it. The V. A. determines all such cases.

## Supervisors Pay Amendment Wins Support

To assure continued efficient county government by giving members of the Board of Supervisors their first pay raise for 33 years, W. S. Rosecrans, chairman, yesterday announced formation of the County Charter Amendment Committee composed of leaders of women's groups, labor unions and commercial organizations.

Facts supporting the plan to increase supervisors' salaries are being mailed by Rosecrans to 20,000 leaders of organizations of veterans, women, labor groups, commercial classifications, educational people and religious units.

"With 3,500,000 people, Los Angeles County still pays its top administrative officials the money they received 33 years ago, when the population was half a million and the dollar was worth twice what it is today," Rosecrans said.

The committee chairman declared that the county's budget has mounted more than 3500 percent, county employees have grown from 3,324 to 19,007, assessed valuations have grown from some half a billion to about three billion and all departments of the county have expanded manifold.

The mayor of Los Angeles, receiving \$3,600 in 1913, now is paid \$18,000. Superior Court judges have quadrupled their pay from \$3,000 to \$12,000 a year, Rosecrans said. Meanwhile, supervisors have had to be content three decades with a pay schedule set before World War I with benefit only of an extra \$4,800 a year paid them by the state for administering the Flood Control District.

"The county's near twenty thousand employees have enjoyed an average pay raise of 42 percent since 1941," Rosecrans said. "The proposed supervisor's boost will cost each citizen only .00714 of a cent."






