Chocolate and cocoa stains are "treated" the same. For white cottons or linens only—dip fabric up and down in hot water; wash in hot suds; bleach any remaining stain with hydrogen peroxide; rinse well. For any washable colored fabric—wash in lukewarm suds, and use carbon tetrachloride to remove any grease spots caused by cream. With either type of fabric, remove stains before laundering.

RESOLVED, FURTHER, that the 8th day of October 1946, at 7:45 o'clock, P.M. of said day, in the COUNCIL CHAMBERS in the CITY HALL, at 1511 Cravens Avenue, Torrance, California, be, and the same is hereby fixed as the time and place for hearing by the Council of said City of all persons interested in objecting to the proposed vacation, and

RESOLVED, FURTHER, that the City Clerk of the City of Torrance is hereby directed to cause this resolution to be published in the manner prescribed by law for the publishing of ordinances of the City of Torrance, in the Torrance Herald, a weekly newspaper of general circulation, published and circulated in said City and the official newspaper thereof, and

RESOLVED, FURTHER, that the City Clerk of the City of Torrance is hereby directed to post, conspicuously along the line of the alley proposed to be vacated, notices of such vacation, in the form and manner required by the legislative act hereinafter mentioned, and

RESOLVED, FURTHER, that the City of Torrance reserves and excepts from the vacation the permanent easements over all of the southerly ten (10) feet of said alley, and the right at any time, or from time to time, to construct, maintain, operate, replace, remove, and renew sanitary sewers, storm drains, and all other public utilities and appurtenant structures in, upon, over and across said alley or any part thereof, and to construct, maintain, operate, replace, remove, renew and enlarge lines of pipe, conduits, cables, wires, poles, and other convenient structures, equipment and fixtures for the operation of gas pipe lines, telegraphic and telephone lines, and for the transportation or distribution of electric energy, petroleum and its products, and water, including access and the right to keep the property free from inflammable materials, and wood growth, and otherwise protect the same from all hazards, in, upon and over the alley or part thereof proposed to be vacated, and

RESOLVED, FURTHER, that no buildings shall be constructed over the southerly fifteen (15) feet of said alley, and

RESOLVED, FURTHER, that in the herein proposed vacation of the alley aforementioned, the Council of the City of Torrance hereby elects to proceed under and in pursuance of the Provisions of the Street Vacation Act of 1941 of the State of California (Chapter 250, Statutes of 1941), as amended.
