

# One Big Inning Gives TAL Split In Sunday Bill

Unable to come through when the heat was on, Torrance American Legion bowed to a St. Mary's Athletic club team in the second game of Sunday's doubleheader at Torrance Municipal park, 5 to 4, after taking the 7-inning opener, 4 to 1. Bob McNeal twirled a two-hit masterpiece for the TALAC's in the short first game, losing a shutout on bobbles in the third inning. Meanwhile his mates profited from a big first inning to sew up the contest with four tallies.

With two out in the opening frame, Manager Clay Assmus singled. Hal Jackson walked and Snider drew line on an error, loading the sacks, and Gerald Jackson drove in two with a bingle.

Billy Johnson then knocked one to right, and when the right fielder and the catcher were through kicking the ball around, two more were across. And while Torrance was goose-egging the rest of the game, those four were enough.

The night cap was an uphill fight that didn't quite make the grade, with a last-inning rally by TALAC's lacking one run of tying the score. Quinn, twirling for the visitors, allowed 12 hits to Swayne Johnson's 7; dealt out 5 walks to Johnson's 2 and whiffed only 2 compared with 10 in the first.

But somehow, when the runners were on base and the pinch was on, he bore down to end the rally.

Doing his best to pull his game out of the fire, Torrance's twirler Swayne Johnson came up with the sacks empty in the eighth inning and poled one of the longest homers ever seen in the park, a tremendous clout that cleared the barrier with yards to spare.

Defensive star of the second game was Gerald Jackson, who had 10 chances at the hot corner without a miscue. However, Billy Johnson, at short, was charged with fielding lapses which proved the margin of defeat. Scores:
