(a) This includes astrology, palmistry, phrenology, life-reading, fortune telling, cartomancy, clairvoyance, crystalgazing, mediumship, prophecy, augury, divination, magic, or necromancy, where a fee is demanded or received for the exercise or exhibition of this art or where an exhibition thereof is given at any place where an admission fee is charged, and provided that, in the event of a revocation thereof as herein-after provided, the City Council may in its discretion order the return of a part thereof; and provided that no license shall be issued under this subdivision unless the applicant upon admission from the City Council of said City. The City Council shall have the right at any time without notice to cancel any license issued under this subdivision, if, in its judgment, licensee has failed to comply with the laws and regulations of the City of Torrance. If, in the opinion of the City Council, it may thereupon instruct the City Clerk to issue such license; and provided, further, that the Chief of Police shall have the power to temporarily suspend such license, when in his opinion such place of business is not being properly conducted and that immediately thereafter such matter shall be placed before the City Council in writing which Council shall, upon reasonable notice to the holder of such license, proceed to hear and determine such matter and that thereupon the Council shall have the right to cancel any such license if, in the opinion of said Council, the public health, safety and morals require such action. (20) Boxing contest, wrestling contest or sparring exhibition, \$25.00 per day. (a) Provided that no license shall be issued under this subdivision without first making formal application to the City Planning Commission; the City Council shall have the right to refuse any or all applications made under this subdivision, and to revoke any license issued pursuant to this subdivision in its discretion; a permit shall first have been secured from the Police Department. (10) Airfield, airport or landing field, \$50.00 per annum. (11) Ball bond brokers, \$50.00 per annum. (12) Bakeries, selling at retail or wholesale, baked goods produced in such bakery, \$24.00 per annum. A health permit is required. (13) Barber shop, \$24.00 per annum. (14) Barber supplies, \$24.00 per annum. (15) Beauty parlor, hairdressing, manicuring or similar business, \$24.00 per annum. (16) Billiard parlor or pool hall, \$50.00 per annum, plus \$5.00 per annum for each pool table. (38) Drug store, \$24.00 per annum. (39) Electric maintenance, \$24.00 per annum. (40) Feed store and/or pet shop, \$24.00 per annum. (41) Ferries, \$24.00 per annum. (42) Five and ten cent store, \$24.00 per annum. (43) Florist, \$24.00 per annum. (44) Frozen food products, \$24.00 per annum. (45) Furniture store, \$24.00 per annum. (58) Junk, second-hand, waste materials dealers (miscellaneous), \$100.00 per annum. (59) Laundry from which laundered articles are delivered by wagon or other vehicle, whether owned or operated by such firm or corporation or other persons, \$100.00 per annum. (a) A separate license shall be required for each person, firm or corporation, or fictitious name, under whose name the business is conducted. (b) For the purpose of this ordinance, a laundry is defined as a place where clothes are washed or ironed, or are both washed and ironed, for compensation, provided that the term "laundry" shall not be considered to include any place where the work is done or performed by the members of one family, or where no persons are employed for compensation. (60) Laundry route on which any wagon, vehicle or other agency is operated or maintained for the purpose of collecting or delivering laundry work to and from any laundry situated outside the limits of the City of Torrance, \$100.00 per annum per vehicle. (a) A separate license shall be required for each person, firm or corporation, or fictitious name under whose name the business is conducted. (61) Laundry (self-service), \$24.00 per annum. (62) Linen supplies, \$36.00 per annum per vehicle. (63) Lunch wagon, selling sandwiches, lunches, drinks, or edibles of any description,

from handcart, stands, trays or baskets, upon the public streets of Torrance, \$24.00 per annum for each handcart, stand, tray or basket. Lunch wagon selling sandwiches, lunches, drinks or edibles of any description upon the public streets of Torrance from any wagon or automobile, \$36.00 per annum for each such vehicle. (a) No license shall be issued under this subdivision until a permit has been first obtained from the City Council, and provided that said City Council shall have the right to grant or refuse any and all applications made under this subdivision, and to revoke any license issued pursuant to this subdivision, at its discretion. (64) Lumber yard, \$24.00 per annum. (65) Manufacturers, \$24.00 per annum. (66) Massage parlors, \$24.00 per annum. (67) Meat store, wherein meat, poultry or fish is sold at retail or wholesale from a regularly established place of business in the City of Torrance, \$24.00 per annum. (79) Photographers, \$24.00 per annum. (80) Pin ball machines, \$24.00 per annum, plus \$5.00 per annum for each machine in excess of one. (81) Plumbing store, \$24.00 per annum. (82) Police Patrol, \$50.00 per annum. (a) No license shall be issued under this subdivision until a permit has been first obtained from the City Council. (83) Printing and publications, \$24.00 per annum. (84) Public address system or sound truck, \$1.00 per day. (85) Radio store or repair shop, \$24.00 per annum. (86) Real estate brokerage or other commission business, \$24.00 per annum. (87) Repairing refrigerators, washing machines and any other articles not hereinbefore mentioned, \$24.00 per annum. (88) Restaurants, selling or serving meals or lunches to be eaten on the premises, and not herein otherwise mentioned, \$24.00 per annum. (89) Rest homes, \$24.00 per annum. (90) Riding academy, \$24.00 per annum. (91) Rock, sand and gravel, sold or hauled, \$24.00 per annum. (92) Routes: wholesalers or retailers of goods, wares, and other merchandise, not having a regularly established place of business in the City of Torrance and not otherwise classified herein, making deliveries to business establishments in the City of Torrance, \$18.00 per annum per vehicle. (95) Sewing machine agent or soliciting orders for sewing machines and not having an established place of business in the City of Torrance, \$5.00 per day. (96) Sheet metal shop, \$24.00 per annum. (97) Sign painting or construction and installation thereof, \$24.00 per annum. (98) Shoe store or shoe repair shop, \$24.00 per annum. (99) Soliciting and canvassing: \$50.00 per annum per agent if yearly license desired; \$5.00 per day per agent if license for less than one year desired. (100) Soliciting or taking orders for photographic work or selling coupons for special discount offers where the work is to be done outside the City of Torrance, \$36.00 per annum. (101) Sporting goods store, \$24.00 per annum. (102) Stands, highway or street, for selling of goods, wares or merchandise other than food or food stuffs for human consumption, on any portion of the public streets within the City of Torrance, \$24.00 per annum. (a) No license shall be issued for any such stand until a permit is obtained from the City Council. The application for such permit must be accompanied by the written consent of the owner or occupant of the premises abutting immediately upon that portion of the street or highway which the applicant desires to use, and said City Council shall have the right to grant or refuse such permit under this subdivision at its discretion. (103) Stationery store, \$24.00 per annum. (104) Storehouse or warehouse for grain or merchandise of any description, \$24.00 per annum. (105) Tailoring, \$24.00 per annum. (106) Taxi service, \$25.00 per annum per vehicle. (107) Theater, moving picture show or any other exhibition not otherwise provided for in this ordinance, \$24.00 per annum. (108) Tobacco, candy, news stand or counter, \$24.00 per annum. (109) Trucking and transfer, \$24.00 per annum plus \$12.00 per annum per power unit. (110) Upholstering, \$24.00 per annum. (111) Used cars (buying and selling), \$24.00 per annum. (112) Vending machine, owner or operator, \$24.00 per annum. (113) Veterinarian, \$24.00 per annum. (114) Water route (delivering bottled water for domestic use), \$15.00 per annum. (115) Welding, \$24.00 per annum. SECTION 13. For every business or profession not herein provided for, \$24.00 per annum. SECTION 14. In all cases other than those wherein the City Council has reserved the right to cancel a license at its pleasure, or without notice, any license issued pursuant to the ordinance of the City Council may be cancelled by the City Council for any cause deemed by said Council to be for the public interest and convenience; provided, however, that notice of any such intended action on the part of the Council shall be first given to the holder of such license and the holder thereof afforded a reasonable opportunity to appear and be heard in said matter. SECTION 15. That Ordinance No. 295 and No. 235A and any other ordinances or parts thereof in conflict herewith are hereby repealed. SECTION 16. Every person who shall carry on for ten (10) days or less after the Jan. 15 of each year any business or profession, for which a license is required, whether having previously had a license therefor or not, without having first procured a license therefor, shall be required to pay the regular license herein provided for such business or profession or pursuant to an additional \$1.00 for such license; and every person who shall carry on for more than ten (10) days after the Jan. 15 of each year, any business or profession for which a license is required, whether having previously had a license therefor or not, without having first procured a license therefor, shall be required to pay the regular license herein provided for such business or profession or pursuant to an additional \$3.00 for such license, and no license shall be issued until said regular fee and penalty has been paid. SECTION 17. Any person, firm or corporation who shall transact or carry on any trade, business, calling, profession, game, exhibition or show in this ordi-
