Unification Of Schools, Protection Of Taxpayers' Interests Here Asked

Warning of the danger which lurks ahead for Torrance City School District unless a Board of Education which is pledged to carry out the program of the Charter Committee is elected on March 18, Mrs. Evelyn L. Carr, chairman of the Torrance Parents Association, yesterday reminded voters that no candidate except the five running on the Citizens Committee slate has indicated his or her intention on three all-important subjects:

1. Unification of the Torrance school district.

2. Continuing the campaign against Los Angeles City schools to preserve the property here which rightfully belongs to the taxpayers of Torrance for the use of the children of Torrance.

3. Building the school system which Torrance rightfully deserves at the lowest cost to the taxpayer, taking advantage of every cut, yet making the tax dollar which comes from the tremendous \$50,000,000 assessed valuation go as far as possible.

"This election is of far too great importance to have these points passed up by any candidate," Mrs. Carr declared.

"I speak not only for my own candidacy but for the members of the Charter Committee in declaring that the silence of others who seek membership on the Board of Education can prove a threat to the program for a fine Torrance school system which the taxpayers have endorsed at two elections in the past eight months.

"In order for the elementary and high schools of Torrance to be brought under a single, locally elected Board of Education, another election must be held.

"This election will form the Torrance Unified School District with jurisdiction over all schools from kindergarten through high school. The Redondo Union high school district Board of Trustees who have so willingly accepted their task of operating the high school for Torrance next year, know that this has been our plan but actually it is up to the people of Torrance through

W. H. Tolson In Appeal For Okay Of Bond Issue

Urging the approval of the bonds for the new Fire department and Police station, Courtman W. H. Tolson yesterday declared:

"The old central fire station building has been condemned and I, as a city official, do not want to be responsible for any men or equipment who might be in that building because at the slightest quake, explosion or disaster, the building might fall down and trap all equipment and men inside, with disastrous results to the safety and well-being of the department and the community. This statement is not made because we have a bond issue pending, but the bond issue is the result of the building being in the condition in which we find it at this time.

"I cannot conscientiously sanction the continued use of the building, and as an elected official, charged with the welfare and safety of the people of the community, I do not wish to be held responsible for the well-being of this department, as a unit of the government or as associated with the safety of the community, if this bond issue does not carry to provide adequate fire and police department headquarters.

"The building was condemned following the earthquake of 1941. 'Now, it is up to the people.'

Three Days Left To Pay Income Tax—Warning

With only three business days left in which to file federal income tax returns, Collector of Internal Revenue Harry C. Westover today warned Southern California taxpayers that the deadline of March 15 will be rigidly enforced.

"Final 1946 returns are due not later than the close of business on Saturday night," Westover said. "These reports must be made by every individual whose total income was as much as \$500.

"Initial declarations of 1947 estimated taxes are also due on the same date. These estimates must be filed by businessmen and professional men whose income is not subject to withholding. They are also required of employees whose salaries are subject to withholding and who will earn more than \$5,000 plus \$500 for each dependent. Married couples are allowed a salary exemption of \$10,000 plus \$500 for each dependent.

"Minor children who earned more than \$500 last year must file their own tax returns and pay their own taxes. Those minors who earned less than \$500 must file returns in order to secure any refund that might be due.

"Taxes may be paid by personal check, money order, cashier's check, postal note, or express check. Cash should not be sent through the mails. No checks for more than the amount of tax due will be accepted.

"All internal revenue offices will be open from 8:00 a. m. to 10:00 p. m. on deadline day, next Saturday," Westover declared.

Decline Noted In Preventable Diseases Here

With a few exceptions preventable diseases in Los Angeles county are below seasonal averages according to Dr. Henry C. Smiley, Torrance district health officer, following a review of the Los Angeles county weekly health index.

All the contagious diseases of childhood, except diphtheria and poliomyelitis, are lower this year, particularly measles, mumps, scarlet fever, and chickenpox, with whooping cough keeping only slightly below the five-year average with 413 cases as against an average of 488.

Palos Verdes College Council Is Announced

Winfield S. Rash of San Pedro has been elected temporary chairman of the Palos Verdes college council, formed to supplement the work of the college's board of trustees.

Dr. Richard P. Saunders, president of the college said the council will work to bring about a close relationship between the proposed college and the communities of the peninsula. He said that plans are being made "for the opening of the college in temporary quarters in the fall."

A maximum enrollment of 250 boarding students and 50 commuting students is planned when the college is fully developed.
