Private First Class Billy G. Peary, 20-year-old paratrooper, is serving with the 11th Airborne Division as part of the Occupation Army in Japan.

Pfc. Peary's work with the Occupation Army is to enforce the laws of the Military Government, help educate the people so that they will be able to form a democratic government, and allow no insurance to come about.

Drafted into the Service in August, 1945, Pfc. Peary then enlisted into the Regular Army. He took basic training at Fort McClellan, and was shipped overseas in the early part of November.
