McCALL, LASSEL PROMOTED TO NEW COLUMBIA JOBS

The appointment of J. D. McCall as general superintendent at the Pittsburgh, California, plant of Columbia Steel Company was announced today by H. S. Worthington, assistant vice-president in charge of operations. McCall will succeed J. A. White, resigned.

Simultaneously, Columbia Steel announced eight other operational appointments in connection with its new \$25,000,000 sheet and tin plate mill which is now being built at the Pittsburgh Plant.

The appointments include D. E. Rice, assistant general superintendent and Donald W. Lassell, formerly in charge of the Torrancia work's sheet mill, as division superintendent, sheet and tin mill.


New Phone Directory Out
