MARGARIT STREET OTHER RIGHT OF WAY RESOLUTION OF INTENTION

WHEREAS, the Board of Supervisors of the County of Los Angeles, State of California, has on file and on record upon its minutes and on the Board, a report from the engineer in charge of said County recommending the improvement as a health measure, and WHEREAS, the Board of Supervisors has found and determined by resolution that the public convenience and necessity require the construction of sanitary sewers in Margarit Street and other rights of way and that such project is necessary as a health measure.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Los Angeles, State of California, as follows:

SECTION 1. That the public interest and convenience require and that it is the intention of the Board of Supervisors of the County of Los Angeles, State of California, to have the following work to be done and improved, to-wit:

First: The construction of sanitary sewers, house connection sewer lines and appurtenances in MARGARIT STREET between EAST ROAD and the southerly line of DOMINGUEZ STREET.

Second: The resurfacing of the streets in the above mentioned area.

That the said work and improvements be done and performed in accordance with the plans, profiles and specifications therefor filed in the office of the Board of Supervisors in the Hall of Records in the City of Los Angeles, on the 28th day of October, 1947. Reference is hereby made to said plans, profiles and specifications.

That the cost of the proposed work or improvement and for the description of the grade to which this work is to be done, and are made a part hereof.

SECTION 2. That the said contemplated work or improvement, in the opinion of said Board of Supervisors, is more than local or ordinary public benefit, and said Board of Supervisors hereby makes the expense of said work or improvement chargeable upon a district, which district said Board of Supervisors hereby declares to be the district bounded by the following boundaries: to-wit: the proposed district approved by said Board of Supervisors on the 28th day of October, 1947, is on file in the office of said Board.

Reference is hereby made to said map for a full and correct description of said assessment district and said map shall govern for all details as to the extent of said assessment district.

SECTION 3. That serial bonds shall be issued to raise the sum of two hundred and twenty-five dollars (\$250.00) or more remaining unpaid for thirty (30) days after the date of the date of the warrant. Said serial bonds shall extend over a period of two (2) years from the second day of January next succeeding the next October fifteenth following the date of the warrant. On the second day of January every year thereafter the principal sum of the bonds shall be payable in equal proportions of the principal sum of the bonds on the second day of January every year following the date of the warrant, and the interest shall be payable semi-annually by coupon on the second day of January and July, respectively, of each year following the date of said bonds at the rate of six (6) per cent per annum on all unpaid principal and interest.

Said bonds shall be issued in accordance with the provisions of an Act of the Legislature of the State of California, designated as the Act of 1911, and the County Ordinance No. 6248 (Improvement Act of 1911).

SECTION 4. That the proceedings for the assessment of the district herein described shall be had and taken under and in accordance with the Act of the Legislature of the State of California designated and known as a Division 7 of the Streets and Highways Code (Improvement Act of 1911).

SECTION 5. That the proceedings for the assessment of the district herein described shall be had and taken under and in accordance with the Act of the Legislature of the State of California designated and known as a Division 7 of the Streets and Highways Code (Improvement Act of 1911).

SECTION 6. The streets hereinbefore referred to as public streets of the County of Los Angeles, and are located in unincorporated territory in the locality known as Dominguez Street.

SECTION 7. That on the 25th day of November, 1947, at the hour of ten o'clock A.M., of said day, is the day and hour, and the Chambers of the Board of Supervisors in the Hall of Records in the City of Los Angeles, is the place fixed by the Board of Supervisors when and where any and all persons having any objections to the proposed work or improvement or to the proposed grades to which this work is to be done, or to any or all of the foregoing, may appear before said Board of Supervisors and show cause why proposed work or improvement should not be carried out in accordance with this Resolution.

SECTION 8. That the County Engineer shall cause to be conspicuously posted along the streets within the district liable to be assessed, notices of the passage of this Resolution in the manner and in the form required by law.

SECTION 9. The Clerk of the Board of Supervisors shall certify to the passage of this Resolution and shall cause the same to be published for two days in the Torrance Herald, a newspaper published and circulated in the County of Los Angeles, which is hereby designated for that purpose by the Board of Supervisors of said County.

The Board of Supervisors does hereby direct the Clerk thereof to mail notices of the adoption of this Resolution of intention to all persons owning real property proposed to be assessed for the work herein described, whose names and addresses appear on the last equalized assessment roll of the County of Los Angeles, as of the date of the passage of this Resolution, and to cause the same to be mailed to each of the persons so named.
