

# Cuts Violate State Unfair Practices Act

Local merchants who participate in so-called discount schemes can be prosecuted under the State Unfair Practices Act which makes it a misdemeanor punishable by fine and imprisonment, for any retailer to give one person or group of persons a secret discount to the detriment of any other persons buying under the same terms and conditions.

A joint warning to that effect was issued yesterday by M. E. Ridenour, manager of the Better Business Bureau, and Paul Diamond, president of the Retail Division of the Torrance Chamber of Commerce.

The two organizations have just completed a secret investigation of all such schemes in operation.

One such plan, which involved a wholesale and indiscriminate telephone solicitation of thousands of residents throughout Long Beach, has already "folded" and the promoters have left the city, leaving both merchants and unsuspecting customers "holding the bag," it was disclosed.

"No one ultimately profits by such schemes but the promoters," Diamond declared. "Merchants can't stay in business if they give the discounts which some of these schemes portend to offer. If such lowered prices were possible, they should be granted to everyone and not just a privileged few who pay some promoter a fee for secret favoritism.

"The few so-called retailers who do profit from such plans use the simple expedient of reducing the price of a few established items as 'bait' and then upping the regular price on other merchandise so that in the end the glib customer actually pays more for most 'discount' items than they are actually worth," Diamond added.

Due to the peculiar wording of the Unfair Practices Act, the promoter of such schemes assumes no liability of their own by such nefarious plans. It is the unsuspecting merchants who incriminate themselves by participation therein.

"Yes," replied Lincoln, "it appears so."


