Zamperini's Prison Guards Are Sentenced

For beating and abusing Allied prisoners of war, Tsuneo Ishikawa, former Japanese army lieutenant in charge of the Naotsu prisoner of war camp in which Capt. Louis Zamperini spent many months as a prisoner, was sentenced to four years' imprisonment at hard labor by a Yokohama Eighth Army Military Commission on March 24, according to a dispatch from United States Army General Headquarters in Tokyo, Japan. Zamperini, the famous mile runner in the 1936 Olympics and later an army bombardier who survived 47 days on a life raft before being captured by Japanese fishermen, was listed among the 40 victims who were forced to lick their boots to clean them after going to the maggot laden latrine at the Naotsu camp. Yusu Aoki, former medical sergeant at the camp, was recently sentenced to hang while Hiroaki Kono, the camp interpreter, was sentenced to life imprisonment at hard labor, according to the dispatch.

Weed Abatement Notices Posted By L.A. County

Weed Abatement clearing operations will begin April 12, 1948 in various sections of the County and will continue through approximately August 10. Any owner who wishes to clear his own property should notify Weed Abatement Section, in writing, prior to April 12, 1948, giving full legal description by tract block, and lot. Such persons will have until June 15, 1948 in which to remove the weeds, after which time, if not cleared, Weed Abatement crews will proceed to clear, and charges for the work will appear on the 1948 tax bills. In instances, an extension of time may be necessary for owners to clear their properties. Unemployment Check Fraud Case Reported

The first of a series of arrests of persons who have been drawing fraudulent unemployment checks was made known this week by an official of the California Department of Employment. A special investigator for the state reported that Dave Paisley, 33 years, of 2236 218th St., Lomita, pleaded guilty to 24 counts of obtaining unemployment insurance checks while he was still working. He was subsequently sentenced to repay \$240 he had received, to pay a fine of \$100, and received a 90-day jail sentence which was suspended. He was placed on a year's summary probation while repaying the money at the rate of \$20 per month. Paisley was sentenced by City Judge Otto B. Willett. The investigator reported that a number of other cases were under investigation in this area but declined to give any additional information on the grounds that it might hamper the work of the officers.

Health Dept. Raps 'Threats' To Food Men

Owners of food markets in scattered communities have reported to the Los Angeles county health department that they are being solicited for advertising under threat that health department inspectors "might make it tough" on those who refuse. Market owners state that the publication soliciting advertising is sponsored by a certain organization claiming membership of health department employees "who would appreciate a generous spread in the publication." All solicitations were made by telephone, it was reported. Paul Ballinger, director bureau of sanitation, said that none of his inspectors belong to the organization and so far as he knows, no other health department employees are members. He said that the County health department "does not approve of such schemes" and that operators of food establishments need have no fear of implications that sanitary inspectors are influenced by favors to individuals or organizations.
