QUERIES ANSWERED ON 'RESPONSIBILITY LAW'

(CONTINUED FROM LAST WEEK)

Q. If a vehicle owned by me and driven by another person is involved in an accident do I have any responsibilities or duties under the act?

A. If you were driving your car it would be your responsibility to report any accident covered by the law and provide the necessary security. The law is enforced through drivers instead of owners of vehicles. However, if the driver of a motor vehicle owned by you is so severely injured he cannot report, it is your responsibility to do so.

Q. Is the Financial Responsibility report the only one I have to make at the time of an accident?

A. No. In addition to identifying yourself properly to others involved, you must report to law enforcement authorities in writing within 24 hours in case there is death or injury. The report must be made to the local police department if the accident occurred within an incorporated area. Otherwise, it must be made to the California Highway Patrol.

Q. Who are exempt from the law?

A. Operators of vehicles owned by the Federal State and municipal governments and political subdivisions of the State and vehicles owned or operated by a carrier subject to jurisdiction of the Public Utilities Commission of the State or the Federal Interstate Commerce Commission. Self-insurers are exempt from security provisions of the act.

Q. How can I qualify as a self-insurer?

A. If you have more than 25 motor vehicles registered in your name and can satisfy the Department of Motor Vehicles that you are able and will continue to be able to meet judgments obtained against you, a certificate of self-insurance may be issued to you.

Q. Can the information contained in the accident report form be used in any legal action against me?

A. Neither the report information, the department's findings nor the security deposited shall be referred to in any way or be any evidence of the negligence or due care of either party in any damage suit arising from the accident.

Q. What use is made of deposited security?

A. Cash security is deposited by the Department of Motor Vehicles with the State Controller. Other forms of security are deposited with the State Treasurer. Security is used to pay any judgments which might be obtained against you or for settlement of any claims agreed to in writing.

Q. How can security be recovered?

A. Security on deposit or any unexpended balance of security shall be returned to the depositor.

or his representative when evidence satisfactory to the Department of Motor Vehicles has been filed of a release or final adjudication of nonliability, a confession of judgment or acknowledged agreement providing for payment of an agreed amount in installments.

Q. Will I be notified if my license is suspended?

A. Notice of suspension must be sent by the Department to an operator not less than 10 days prior to the effective date of the suspension and shall state the amount required as security.

Q. What are the requirements for a liability insurance policy or surety bond to qualify under the California law?

A. It must be issued by a company authorized to do business in this State. In the case of coverage on an automobile registered outside of the State, the issuing company, if not authorized to do business in the State, must have authorized the Director of Motor Vehicles to accept service on its behalf in any action arising out of an accident. The policy must have a limit of not less than \$5,000 for injury or death to one person, \$10,000 for injury or death to two or more persons and not less than \$1,000 for property damage.

Q. Are there any exceptions to security provisions of the act?

A. Yes. They do not apply to the driver of a motor vehicle involved in an accident wherein no injury or damage to the property of anyone other than himself was caused; to the operator of a legally parked, standing or stopped vehicle, either attended or unattended, if prior to the time the Department would suspend the driver's license or non-resident's driving privilege evidence is filed of a release from liability, judgment of nonliability, confession of judgment or written agreement calling for payment of an agreed amount in installments.

Q. How long will my driver's license remain suspended for non-deposit of security?

A. Until the required security is deposited, until one year has elapsed since the accident without a damage action being instituted or until there is filed with the Department evidence of a release from liability, final adjudication of nonliability, confession of judgment or an acknowledged written agreement to pay an amount in installments.

Q. What if I am involved in an accident and have no valid California driver's license?

A. You will not be allowed a license until you comply with the Financial Responsibility Law.

Q. Can I be required to post more security than the \$5,000, \$10,000 and \$1,000 limits set for liability insurance?

A. No. The law specifically says that security shall not be in excess of these limits.

Q. What form can security take?

A. It may be cash, surety bonds or any type of negotiable paper.

Q. If I consider the required security excessive, can I obtain a reduction in the amount?

A. Any time within six months after the date of an accident, the Department may reduce the amount of security if it believes the amount is excessive. The excess amount will be returned immediately to the depositor.

Q. Does this new law supersede the old civil Financial Responsibility Law that was adopted in 1937?

A. No. The old law remains in effect. It provides for suspension of the driver's license and the registration of a motor vehicle owned by any person who fails for 30 days to satisfy any final judgment for damage to property in excess of \$100 or for damage in any amount because of injury or death.
