He stated that he may take his National loop team to Houghton Park in Long Beach for the next season. He said that he considered re-applying for permission to play in San Pedro but an over-loaded schedule of games at Daniels Field whittled his chance of calling San Pedro a home port during the 1949 season.

After that, "Aggie" comes busting right back with another big 77-lap Roadster Hot Rod show next Wednesday, Aug. 4. All the shows at Carrell Speedway begin with qualifying trails at 7 p.m., and the first race, a trophy dash for the fastest qualifying cars, at 8:30 p.m. In all the shows, inverted starts, that innovation of racing which forces the fastest cars to start last, is in vogue.

The new "Gorgeous George" of boxing, Roy Jennings, who gained his cognomen by entering the ring last week with everything but an umbrella, a valet and an atomizer, will take on Frank Chavez, a rough little fighter from San Pedro. Jennings hails from Redondo Beach.

Certificates for Vets at Local Center

The Veterans Service Center of Torrance today urged veterans who plan on entering school this fall under either the state or federal program, to file now for their certificate of eligibility.

By filing early, veterans can be assured of receiving their first subsistence checks with a minimum of delay. Those veterans who do not secure their certificates prior to registration may have to pay their own fees for tuition, books, and other materials.

Certificates of eligibility may be applied for through the Veterans Service Center at 1339 Post avenue, Torrance. Complete copies of discharge must be submitted when filling.

Bag Limits on Deer, Bear, Birds, Set by Commission

The estimated half a million California hunters who plan to take to the field this fall will find hunting seasons and bag limits generally similar to those set last year by the Fish and Game Commission.

Regulations passed by the Fish and Game Commission in April have now become law and include three separate deer hunting seasons in five California regions, a longer bear season with a larger bag limit, and a 10-day pheasant hunting season.

The south coastal area is composed of San Luis Obispo, Santa Barbara, Ventura, Los Angeles, Orange and San Diego counties, and portions of Kern and Riverside counties. A one-buck limit will apply in this area between Aug. 7 and Sept. 6.

Bow and arrow hunters may take deer with a special permit for a 10-day period preceding the regular hunting season in any area. Under the provisions of a new Commission regulation, bows must have a minimum pull of 50 pounds, and arrows a minimum weight of 457 grains.

California's brown bear, of which there are an estimated 20,000, may be taken by bow or arrow or firearms between Oct. 23 and Dec. 31. Bag and possession limit has been upped to two bears. Seasonal bag limit is two. No trapping is permitted.

Upland game bag limits remain the same as in 1947. Two male pheasants per day and 10 per season may be taken between Nov. 19 and Nov. 28. Eight quail per day and 16 per week may be possessed between Nov. 19 and Dec. 31.

Tree squirrels are legal targets in districts 1, 25, 23 and 13 between Nov. 19 and Dec. 31. Bag limit remains two per day and 12 per season. Hunting for all species of rabbits in six Southern California counties has been set between

Veterans Will Get Dividends on Insurance

J. G. Caldwell, director of the Veterans Service Center, today warned veterans of World War II that writing to the Veterans Administration will only delay payment of dividends on National Service Life Insurance scheduled to be paid almost all former and current policy holders.

Eventual payment of dividends, possibly within a year, is the result of a recent Supreme Court decision which made possible the release of perhaps as much as \$2 billion in surplus.

Caldwell said actual policies also will be issued after several months to those who have converted their insurance from the term plan.

Rifle Ban Postponed

The proposed ban on the use of rifles of less than 25 caliber in hunting big game, and other firearms rulings which were to take effect this year have been postponed by the California Fish and Game Commission. The regulations will be enforced after July 1, 1949.


