## Open House to End Recreation Program

Promising fun for all, the 1951 Summer Recreation Open House program will open doors tonight at the Civic Auditorium, 7:30 p.m.

Featured on the two-hour program will be extensive craft exhibits, talent acts, presentation of service, softball and swim awards, the coronation of the Playground King and Queen and the showing of "Let's Play," a 40-minute color motion picture showing all phases of summer recreation activities.

Judges for the King and Queen selection will be Doctors Emmory Schiller and William Sidders along with Miss Ruth Clark, Miss Agnes De Labarre will judge crafts.

## Importance of Reporting Animal Bites Immediately Emphasized

The extreme importance of immediately reporting animal bites to the nearest health department was emphasized this week by Dr. Roy O. Gilbert, County Health Officer.

Dr. Gilbert added that any warm blooded animal may be rabid, and that the State Department of Public Health has designated Los Angeles County to be a rabies endemic area. In such designated areas it is a legal responsibility to report such bites, whether or not the animal is suspected of having rabies.

Certain cases have pointed up the importance of quick reporting. Last year a man, licked on the hand by his rabid dog, died of rabies and, frequently, as happened last week in Santa Monica, it is necessary to start Pasteur treatment on children because the biting dog cannot be found.

**DOG OBSERVED**  
The County Health Officer emphasized that animals suspected of rabies should be captured alive if possible. If for some reason the animal must be killed, it is essential that the head be preserved intact for laboratory examination. Observation of an animal under confinement or in the laboratory, may prove that a person needs no treatment other than local medication for the bite wound.

Dr. Gilbert stated that animal bites should be reported promptly to the local health department office.

**NEEDED INFORMATION**  
As much of the following information as possible should be included in the report: name; age; and address of person bitten; date and address where bite occurred; location of bite and description of wound; description of the animal, and the name and address of the dog's master when possible.

Immediate attention by a physician is warranted in all bite cases, the health officer stated. When a doctor is not immediately available bite wounds may be thoroughly cleansed and irrigated with a strong soap or detergent solution.

### Second Session Opens

With nearly a thousand students in attendance at the college and its branches, Harbor Junior College's second summer session is now in its second week. At the close of registration, August 10, enrollment figures of full and part-time students showed a grand total of 974 students, almost as great an attendance as that of the first summer session.


