TORRANCE HERALD ORDINANCE NO. 578 AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TORRANCE DECLARING DEPOSITING OF RUBBISH ON CITY STREETS OR ALLEYS A NUISANCE.

The City Council of the City of Torrance does ordain as follows:

SECTION 1: That it is unlawful for any person, firm or corporation to throw, or cause to be thrown, or leave any glass, broken-ware, dirt, rubbish, garbage, cleanings from oil pumps, cleanings from oil structures, or filth upon the streets or alleys of the City of Torrance, or upon any other structure, or filth.

SECTION 2: That it is hereby declared to be a nuisance in the City of Torrance to maintain, or cause to be maintained, on any private premises, except such as are required by the Superintendent of Streets of the City of Torrance, any glass, broken-ware, dirt, rubbish, garbage, cleanings from oil pumps, cleanings from oil structures, or filth upon the streets or other structures, or filth.

SECTION 3: Nothing contained herein, however, shall apply to the ordinary accumulation of dirt and debris through the ordinary usage of a private residence, or residence, and general welfare of the City of Torrance and shall be in effect immediately after its passage. The following is a specific statement showing the urgency of this Ordinance:

SECTION 4: Certain persons, firms and corporations in the City of Torrance are maintaining, and causing to be maintained, nuisances in the contemplation of this Ordinance, and thereby menacing the public peace, health and general welfare.

SECTION 5: Any person, firm, partnership or corporation violating any of the provisions of this Ordinance shall be guilty of a misdemeanor and each violation shall be considered a separate offense thereof. Such violator, upon conviction, shall be punished by imprisonment in the City Jail of the City of Torrance, or in the County Jail of the County of Los Angeles, for a period of time not to exceed six (6) months or by a fine not to exceed five hundred dollars (\$500) or by both such fine and imprisonment at the discretion of the Court.

SECTION 6: If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Clerk of the City of Torrance hereby declares that it would have every section, subsection, sentence, clause and phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional. It is intended by the City Council that each section, subsection, sentence, clause and phrase thereof is to be considered and held severable.

SECTION 7: The City Clerk shall certify to the passage and adoption of this Ordinance and cause the same to be published once in the Torrance Herald, a weekly newspaper published, printed and circulated in the City of Torrance, and said newspaper is hereby designated for that purpose.

Introduced, approved and adopted this 13th day of November, 1951.

Insurance Agent Union Threatens Strike Saturday

A threatened walk-out of the 15,000 district agents of the Prudential Insurance Company was reported here late yesterday by Harry C. Harper, district manager of the company, with offices at 1603 Craven avenue.

Harper reported that negotiations between the company and representatives of the Insurance Agents International Union of the AFL were discontinued Tuesday after failure to reach an accord.

The union has terminated the existing contract, effective December 1, and has threatened to strike if its demands are not met.

The union originally demanded increases totaling \$64,000,000 a year, Harper said. They later reduced the demands to \$35,000,000 (about \$45 weekly increase per agent).

The huge insurance company has offered higher commission rates and a change in the present retirement plan to make it a non-contributory plan effective last January 1.

This would relieve the average agent of a weekly contribution of \$3.14 and would result in a \$150 average lump sum refund of this year's contribution, Harper pointed out.

"We sincerely hope that none of our agents will be led into a strike based on such unreasonable grounds," a company spokesman said. "Our district agents are among the best compensated in the entire industry, receiving an average of more than \$110 weekly in cash earnings and company's paid welfare benefits. Some earn \$10,000 or more a year," he added.

Harper pointed out that none of the negotiations had been conducted locally.

Dangers of Tetanus Related By L. A. County Health Official

Tetanus, commonly called lockjaw because one of the early symptoms of the disease is painful contractions of the jaw muscles, is caused by a tiny germ which produces a nerve poison.

The germ in its spore form inhabits soil that has been contaminated with manure from animals, particularly the grass-eating animals. Consequently, tetanus can most often be traced to infections contracted in stables and farm yards, and from garden soil fertilized with raw manure.

Contrary to popular conception, it is not necessary to contract tetanus from a severe puncture wound. A recent study has revealed that only 20 percent of the group studied exhibited types of wounds for which a physician would ordinarily be consulted. Splinters, wounds, blisters on the feet, or any wound where the infecting germ can grow protected from the air, may be breeding places for the germ.

Neck Gets Stiff

In addition to the spasms of the jaw muscles, early symptoms of tetanus include stiffness of the neck muscles. Spasms of other muscles of the body may occur later in the course of the disease. Noises and jarring may cause violent convulsions.

Tetanus, caused by wounds contaminated with dirt and filth of the battlefield, was formerly a major cause of casualties among the armed forces, but the discovery of a preventive treatment now routinely given to men and women entering the armed services, has virtually eliminated this hazard.

Whenever a wound is known to be contaminated with dirt of any kind, a physician should be consulted at once to decide whether or not a preventive anti-tetanus injection is necessary.
