One Hurt When Car Hits Pole

A Comp Roberts soldier was painfully struck when his 1951 sedan struck a power utility pole at Figueroa and Sepulveda, Sunday night, demolishing the entire front portion of the car. Edwin L. Morey, Jr., Los Angeles, was traveling at a high rate of speed on Sepulveda Blvd. when his auto rammed head-on into the pole, according to Highway Patrol investigators. The impact sheared off a 12-inch post abutting the pole. His car then spun around and lodged itself under the guy-wire. It took efforts of deputy sheriffs, highway patrolmen and ambulance attendants to gain entrance to the victim in the wrecked car. He was taken to Harbor General Hospital and later transferred to Ft. MacArthur. Patrol officers H. G. Ward and Lloyd Watson investigated.
