reports, requests, and demands brought before the council. Q. Would you air your views on city taxes? "I am for adhering to the hold-the-line policy on taxes. With the city growing as rapidly as it is, I do not feel we can trim the amount of services needed by the residents. If the council considers trimming the budget, it is bound to look for the most expensive item. That would be wages, since 70 percent of last year's budget was for salaries. We cannot cut the wages of city employees and expect to retain the high type personnel now employed or remain in the competitive labor market. To hold-the-line on taxes, we must operate the city as a business. The budget must be free of 'political favors.' The money must be spent intelligently and judiciously."
