

# Officials Show New Lifesaving Methods Here

George Powell, assistant director of Civil Defense for Torrance and Paul R. Young, assistant director of first aid and water safety service for the Los Angeles Red Cross, demonstrated the new back pressure-arm lift method of artificial respiration to an interested group in the Civic Auditorium Monday evening.

The new method is designed to replace the former Schaef method of artificial respiration which has been in common usage for several years.

With only the minimum of training, a person can be more efficient with the new method than the highly trained Schaef technician.

Another advantage of the new system, according to Young, is that the new method can be utilized effectively by a relatively small person.

Pamphlets describing the new method are available at the Civil Defense office, 1754 Torrance Blvd., Powell said.

**ORDINANCE NO. 602**  
AN ORDINANCE OF THE CITY OF TORRANCE ESTABLISHING CERTAIN TRAFFIC CONTROL MEASURES PURSUANT TO ARTICLE IV, ORDINANCE NO. 446  
The City Council of the City of Torrance does hereby ordain as follows:  
THAT public convenience and necessity requires that traffic control installations be established on certain streets in said City.  
NOW, THEREFORE, IT IS HEREBY ORDERED BY THE City Council of the City of Torrance that the following streets be established on the following streets:  
1. Four-way STOP at Via Monte D'oro and Calle Miramar.  
2. Two-way STOP on Eborado Street at Hillside Avenue.  
3. One-way STOP on Pennsylvania Avenue at Sepulveda Boulevard.  
4. One-way STOP on Arlington Avenue at north side of Bartoli Avenue.  
The aforementioned regulatory signs have been determined by the Traffic Commission as necessary, as per Ordinance No. 446, Article IV, and in accordance with the provisions of said Ordinance and Article, is hereby authorized and directed to erect such signs.  
The City Council hereby declares that the increased usage by the automobile driving public on the streets has created a traffic hazard which demands the immediate preservation of the public peace, health and safety of all citizens traversing said streets, whether by automobile or as pedestrians, and, basing its conclusion upon the aforesaid statement, declares that an urgency exists and that this ordinance shall take effect and be in full force immediately after the passage and adoption hereof.  
The City Clerk will certify to the passage and adoption of this Ordinance and cause the same to be published once in the Torrance Herald, a semi-weekly newspaper, printed and circulated in the City of Torrance, and said newspaper is hereby designated for that purpose.
