### Employer Tax Warning Given

Robert C. Kirkwood, chairman of the Franchise Tax Board, announces that it will be permissible for employers to file copies of Federal Forms W-2 instead of State Forms 599 to report wages of their employees only if they clearly indicate on the W-2 whether the employee is single or married.

Information returns for 1953 must be filed for all their single employees who earned \$2000 or more and for all their married employees who earned \$3500 or more.

State Summary Forms 599 must accompany either Forms 599 or W-2 and are to be filed on or before Feb. 15, 1954.

Employers are requested to mail the forms to the Franchise Tax Board at Sacramento, whenever possible.
