Judge Raycraft Declares Glenn Guilty of Theft

Wade Glenn, formerly associated with the now defunct Post Avenue Motors, was found guilty this week of grand theft when Long Beach Superior Court Judge Joe Raycraft determined that Glenn had sold the same motor vehicle twice.

Evidence introduced into the case by Deputy Dist. Atty. Richard E. Maher indicated that Glenn first sold the car in question to a Post Avenue Motors salesman, and a contract for \$2134 covering the sale was sold to P. E. Johannes, owner of a Long Beach finance firm.

During the trial before Judge Raycraft last week, Johannes testified that he received only two payments on the contract and then discovered that the same automobile had been sold to someone else.

Second buyer of the auto, J. C. Smith, of 804 Cota Ave., said he bought the auto from Glenn in early 1953 and signed a conditional sales contract for \$2550. Smith financed the purchase through a Torrance bank, leaving the Johannes firm with a worthless contract for \$2134.

Glenn testified that he entered bankruptcy before he was able to repay the \$2134 to Johannes.

Sentencing of Glenn was set for May 11.
