NATURAL GAS FRANCHISE Herein is hereby granted to the Grantee for the term of twenty-five (25) years from and after the date of the ordinance...

COMPENSATION TO THE CITY Amount of fee. A consideration of the franchise is hereby granted. The Grantee shall pay annually to the City...

REMOVAL OF FACILITIES At the time of installation, relocation, or termination of this franchise or of the permanent discontinuance of the use of its facilities...

REARRANGEMENT OF FACILITIES A. Expense of Grantee. If any of the Grantee's facilities shall endanger the public in the use of the public streets or interfere with or obstruct the use of any street...

REARRANGEMENT OF FACILITIES B. Expense of Other. The Grantee shall have the right to require the Grantee to rearrange or relocate any of its facilities...

REARRANGEMENT OF FACILITIES C. Re-arrangement of the Facilities of Others. Nothing in this franchise contained shall be construed to require the City to move, alter or relocate any of its facilities...

REARRANGEMENT OF FACILITIES D. Notice. The Grantee shall be given not less than thirty (30) days written notice to the City of any rearrangement or relocation of any of its facilities...
